ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (INDEPENDENCE SQUARE) ORDER, 1994

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Independence Square) Order, 1994.

2. This Order comes into operation at 6.00 a.m. on Friday, 21st January, Commencement and ceases at 6.00 a.m. on Sunday, 20th February, 1994.

- 3. Parking is prohibited on the following roads:
 - (a) Independence Square North, between Frederick Street and prohibited George Street;
 - (b) Independence Square South, between George Street and Broadway.
- 4. Taxis shall operate as follows:
 - (a) Broadway taxis plying for hire from the eastern side and western taxi and side of Cipriani Circle shall ply for hire from the northern side stand of Independence Square South, between Broadway and Chacon Street;
 - (b) Chaguanas "round the road" taxis plying for hire from the southern side of Independence Square North, between Charlotte Street and George Street shall ply for hire from the northern side of Independence Square North, from a point five metres West of George Street to a point five metres East of Charlotte Street;
 - (c) San Fernando maxi-taxis plying for hire from the southern side of Independence Square South, between Henry Street and Charlotte Street shall ply for hire from the northern side of South Quay, from a point five metres West of George Street to a point five metres East of Henry Street;
 - (d) Chaguanas maxi-taxis plying for hire from the southern side of Independence Square South, between Henry Street and Charlotte Street shall ply for hire from the eastern side of George Street, between Independence Square South and South Quay, from a point five metres North of South Quay to a point five metres South of Independence Square South;
 - (e) San Fernando/Chaguanas taxis plying for hire from the southern side of Independence Square North, between Henry Street and Charlotte Street shall ply for hire from the northern side of Independence Square North, from a point five metres West of Charlotte Street to a point five metres East of Henry Street;

- (f) Arima/Sangre Grande taxis plying for hire from the northern side of Independence Square South, between Broadway and Henry Street shall ply for hire on the western side of lower Henry Street facing North, from a point five metres North of South Quay to a point five metres South of Independence Square South; and
- (g) Tunapuna/Curepe taxis plying for hire from the southern side of Independence Square North, between Cipriani Circle and Henry Street, shall ply for hire on the eastern side of lower Henry Street facing North, from a point five metres North of South Quay to a point five metres South of Independence Square South.

Traffic directional change 5. Vehicular traffic that normally proceeds South on Henry Street, between Independence Square South and South Quay shall now proceed in a northerly direction only.

Vehicular traffic permitted 6. Vehicular traffic is permitted to travel North along George Street, between Independence Square South and Independence Square North.

Removal and impounding of vehicles uniawfully parked Chap. 48:50

7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
