## THE CUSTOMS (AMENDMENT) REGULATIONS, 1994

1. These Regulations may be cited as the Customs (Amendment) Citation Regulations, 1994.

2. In these Regulations, the Customs Regulations are referred to as Interpretation "the Regulations".

3. Regulation 55 of the Regulations is repealed and substituted by the Regulation 55 following regulation:

repealed and a regulation substituted

Schedule I

55. (1) No goods may be discharged from an aircraft "Delivery to be authorized or ship, other than a steamship, without permission of the proper Officer.

> (2) No goods deposited on importation in a customs area may be removed from that area unless the proper Officer-

- (a) authorizes delivery of the goods in writing on the delivery order or bill of lading; and
- (b) issues a note in the Form C87 showing the goods in respect of which delivery is authorized."

4. Schedule 1 to the Regulations is amended in the list of forms-

- amended (a) by inserting after the item "Form C86. Bill of Sight covered by Bond.", the following item: "Form C87. Cargo Delivery Note." and
- (b) by inserting immediately after Form C86 the following form:
