ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(ARIMA FEST) ORDER, 1994

1. This Order may be cited as the Traffic Restriction (Arima Fest) Citation
(Temporary Provisions) Order, 1994.

2. This Order has effect between the hours of 8.00 a.m. and Duration
10.00 p.m. on Saturday, 13th August, 1994.

3. Vehicular traffic entering Arima shall proceed—

Vehicles
entering
Arima

- (a) from the west, along Eastern Main Road from Hollis Avenue north into King Street, east into Sanchez Street, along Prince Street, east into El Camen Street continuing east, south into Guanapo Street, then proceed east out of Arima;
- (b) from the east, along Guanapo Street, south into Quesnel Street, continuing west and then south into Pro Queen Street;
- (c) from the south—
 - (i) along Cocorite Street, then west into Maurice Avenue;
 - (ii) along O'Meara Road, into Queen Mary Avenue, east into Hollis Avenue and north into King Street.

4. Vehicles entering the Arima Fire Station and the Arima Police Station shall enter by way of Green Street.

5. Vehicular traffic is prohibited on the following roads:

Roads closed
parking
prohibited

- (a) Broadway, between St. Joseph Street and Raglan Street;
- (b) Queen Street, between Sorzano Street and Hollis Avenue;
- (c) Hollis Avenue, between Industry Street and Queen Street;
- (d) Prince Street, between Sorzano Street and Broadway;
- (e) Woodford Street, between Hollis Avenue and Sorzano Street;
- (f) Cocorite Street, between Broadway and Maurice Avenue.

**Parking
prohibited****6. Parking of Vehicles is prohibited on the following streets:**

- (a) Quesnel Street, between Guanapo and Pro Queen Streets;
- (b) Moreno Street, between Guanapo and Columbus Streets;
- (c) Sorzano Street, between Columbus and King Streets;
- (d) Sanchez Street, between King and Prince Streets;
- (e) King Street, between Hollis Avenue and Sanchez Streets;
- (f) Anglican Street, between Industry and King Streets;
- (g) Green Street, between Cocorite Road and King Street;
- (h) Farfan Street, between Cocorite Road and King Street;
- (i) Prince Street, between Broadway and Sorzano Street.

**Temporary
taxi stands****7. (1) Taxis and maxi-taxis plying the Port-of-Spain/Arima route shall operate from St. Joseph Street.**

(2) Taxis which operate from Hollis Avenue shall operate from Pro Queen Street, south of De Verteuil Street.

(3) Taxis which operate from Devenish Street shall operate from De Verteuil Street.

(4) Taxis which operate from Farfan Street shall operate from Loubon Street.

(5) Taxis which operate from Broadway, east of the Dial, shall operate from Guanapo Street, east of Raglan Street.

(6) Taxis plying the Sangre Grande route shall proceed north into Moreno Street, west into Columbus Street, west into Sorzano Street, south into Raglan Street and re-enter east into Guanapo Street.

8. (1) Buses approaching Arima from the east, along Guanapo Street, shall proceed south into Quesnel Street, continuing south into Pro Queen Street, west along Robinson Circular, into Queen Mary Avenue, then into Hollis Avenue unto the terminus.

(2) Buses proceeding to Sangre Grande shall proceed north along King Street, east along Sorzano Street, then east along Columbus Street into Moreno Street, then east into Guanapo Street.

(3) Buses proceeding to Port-of-Spain shall proceed north along King Street, west along Industry Street, then onto John Shaw Avenue.

**Parking
restricted****9. Motorists may park their vehicles on the undermentioned Streets as follows—**

- (a) on the western side only of St. Joseph Street, between Farfan and Longden streets;
- (b) on the southern side only of Guanapo Street, between Moreno and Raglan Streets.

10. Without prejudice to any other liability incurred by the Removal and
commission of a summary offence, vehicles found parked in impounding of
contravention of this Order may be removed by the Police and impounded vehicles
and dealt with in accordance with section 108(1)(b) of the Motor Vehicles unlawfully
and Road Traffic Act. parked
