ORDER

MADE BY THE PRESIDENT UNDER SECTIONS 7 AND 10 OF THE CUSTOMS ACT

THE CUSTOMS (IMPORT DUTY) (CARIBBEAN COMMON MARKET)
ORDER, 1990

1. This Order may be cited as the Customs (Import Duty) (Caribbean Citation Common Market) Order, 1990.

2. The Schedule to the Customs (Import Duty) (Caribbean Common Market) Order is amended by substituting for the common market rates of duty applicable to the items listed below the following new common market rates of duty—

2208.902	Rum Punch	\$28.95 per litre Alc./Vol. and so in proportion for any part of a litre or for any greater or lesser strength
2208.50	Gin	\$61.40 per litre Alc./Vol. and so in proportion for any part of a litre or for any greater or lesser strength
2208.30	Whisky and blended Whisky	\$61.40 per litre Alc./Vol. and so in proportion for any part of a litre or for any greater or lesser strength
2208.901	Vodka	\$61.40 per litre Alc./Vol. and so in proportion for any part of a litre or for any greater or lesser strength
2208.902	Cordials and Liqueurs	\$61.40 per litre Alc./Vol. and so in proportion for any part of a litre or for any greater or lesser strength
