REPUBLIC OF TRINIDAD AND TOBAGO

APPROVED PHARMACEUTICAL PREPARATIONS

(The Antibiotics Act, Chap. 30:02 of the Laws of Trinidad and Tobago)

IN EXERCISE of the powers conferred upon him by section 5 of the Antibiotics Act, Chap. 30:02 of the Laws of Trinidad and Tobago, the Minister of Health on the recommendation of the Antibiotics Control Committee, has given approval for the following Antibiotics preparations to be imported into Trinidad and Tobago.
