BYE-LAWS

MADE BY THE PILOTAGE AUTHORITY WITH THE APPROVAL OF THE  
MINISTER UNDER SECTION 7 OF THE PILOTAGE ACT

THE PILOTAGE (AMENDMENT) BYE-LAWS, 2019

1. These Bye-laws may be cited as the Pilotage (Amendment) Citation  
Bye-laws, 2019.
2. In these Bye-laws, “the Bye-laws” means the Pilotage Bye-laws. Interpretation

3. Bye-law 14(1)(b) of the Bye-laws is amended by deleting the words “three hundred and forty dollars” and substituting the words “three hundred and sixty-five dollars”. Bye-law 14

4. Bye-law 15(1) of the Bye-laws is amended in— Bye-law 15  
amended
  - (a) subparagraph (a)(i), by deleting the words “one thousand dollars” and substituting the words “four thousand, two hundred and ninety-two dollars”;
  - (b) subparagraph (b)(i)—
    - (i) by deleting the word “.50” and substituting the word “.54”; and
    - (ii) by deleting the word “4,000.00” and substituting the word “4,292.00”;
  - (c) subparagraph (b)(ii)—
    - (i) by deleting the word “.50” and substituting the words “.54”; and
    - (ii) by deleting the word “3,500.00” and substituting the word “3,758.56”;
  - (d) subparagraph (b)(iii)—
    - (i) by deleting the word “.50” and substituting the words “.54”; and
    - (ii) by deleting the word “3,000.00” and substituting the word “3,224.52”;

- (e) subparagraph (b)(iv)—
  - (i) by deleting the word “.50” and substituting the word “.54”; and
  - (ii) by deleting the word “3,000.00” and substituting the word “3,224.52”;
- (f) subparagraph (b)(v)—
  - (i) by deleting the word “.25” and substituting the word “.54”; and
  - (ii) by deleting the word “3,000.00” and substituting the word “3,224.52”.

- (a) paragraph (a), by deleting the words “\$175.00” and substituting the word “\$236.60”;
  - (b) paragraph (b), by deleting the words “\$300.00” and substituting the word “\$405.60”;
  - (c) paragraph (c), by deleting the words “\$300.00” and substituting the word “\$405.60”;
  - (d) paragraph (d), by deleting the words “\$300.00” and substituting the word “\$405.60”;
  - (e) paragraph (e), by deleting the words “\$300.00; and” and substituting the words “\$405.60;”;
  - (f) paragraph (f), by deleting the word “\$300.00” and substituting the words “\$405.60;”;
  - (g) by inserting after paragraph (f), the following paragraphs:
    - “(g) Tobago at the rate of \$351.52; and”
    - “(h) Galeota at the rate of \$676.00.”.

  - (b) subparagraph (a)(ii), by deleting the words “\$2,000.00” and substituting the word “\$2,575.56”;
  - (c) subparagraph (a)(iii), by deleting the words “\$2,200.00” and substituting the word “\$2,832.44”; and
  - (d) subparagraph (a)(iv), by deleting the words “\$4,400.00” and substituting the word “\$5,664.88”.

(Bye-laws 14 and 33)

<i>Description of ship</i>	<i>Dues payable in or out of any compulsory pilotage area</i>
Tankers	\$1,425.00 plus an additional charge of 45 cents per ton for each ton in excess of 2,500 gross tonnage
Container ships	\$1,425.00 plus an additional charge of 26 cents for each ton in excess of 2,500 gross tonnage
Passenger ships	\$950.00 plus an additional charge of 17 cents for each ton in excess of 2,500 gross tonnage
Other ships up to 2,500 gross tonnage	\$1,425.00
Other ships up to 15,000 gross tonnage	\$1,425.00 plus an additional charge of 26 cents per ton for each ton in excess of 2,500 gross tonnage
Other ships in excess of 15,000 gross tonnage	\$1,425.00 plus an additional charge of 45 cents per ton for each ton in excess of 2,500 gross tonnage.”.
