# THE DANGEROUS DRUGS (AMENDMENT OF THE SECOND SCHEDULE) ORDER, 2019

1. This Order may be cited as the Dangerous Drugs (Amendment Citation of the Second Schedule) Order, 2019.

2. (1) Subject to subclause (2), this Order comes into operation on Commencement 18th November, 2019.

(2) Clause 3(c) comes into operation on 3rd February, 2020.
