MADE BY THE PRESIDENT UNDER SECTION 5(3) OF THE

THE LAND ACQUISITION (DECLARATION OF ACQUISITION)  
ORDER, 2022

1. This Order may be cited as the Land Acquisition (Declaration of Acquisition) Order, 2022.

2. The parcel of land—

(a) comprising approximately 0.5793 hectares, more or less, situate at Light Pole LV15, along the eastern side of the Manzanilla/Mayaro Road, Ortoire Village Mayaro, in the Ward of Guayaguayare, in the County of Mayaro;

(b) described in the Schedule and coloured raw sienna on a plan of survey signed by the Director of Surveys and dated 16th January, 2001 and executed under Survey Order No. 118/1999 and filed in the Surveys and Mapping Division; and

(c) having been declared by the President by Order by Legal Notice No. 261 of 2020 as land required for a public purpose and approved for such purpose by the Parliament of the Republic of Trinidad and Tobago by Resolution of the Senate on the 2nd day of July, 2020, and the House of Representatives on the 3rd day of July, 2020, has been acquired for the following purpose: the improvement of road alignment for bridge construction.

SCHEDULE

Four parcels of land together comprising approximately 0.5793 hectares more or less, situate at Light Pole LV15, along the eastern side of the Manzanilla/Mayaro Road, Ortoire Village, Mayaro, in the Ward of Guayaguayare, in the County of Mayaro and described as follows:

(a) A parcel of land comprising 101.1 square metres said to belong now or formerly to Delores Bute;

- (b) A parcel of land comprising 655.5 square metres said to belong now or formerly to Errol Mentor;
- (c) A parcel of land comprising 441.6 square metres said to belong now or formerly to Clunis Baptiste; and
- (d) A parcel of land comprising 4,594.5 square metres said to belong now or formerly to George Bovell.

The parcel is more particularly shown coloured raw sienna under Survey Order 118/1999 and signed by the Director of Surveys on 16th January, 2001 and referenced as JC 191 in the Vault of the Office of the Director of Surveys, No. 118, Frederick Street, Port-of-Spain.
