REPUBLIC OF TRINIDAD AND TOBAGO

Act No. 33 of 1997

[L.S.]

AN ACT to vest of the undertaking in Trinidad and Tobago of Premier Oil plc formerly known as Premier Consolidated Oilfields PLC, a company incorporated in Scotland, in Premier Oilfields of Trinidad Limited, a company incorporated in Trinidad and Tobago.

[Assented to 31st October , 1997]

WHEREAS Premier Oilfields of Trinidad Limited (hereinafter referred to as "PREMIER") a company incorporated in Trinidad and Tobago under the Companies Ordinance, Ch. 31. No. 1 has agreed to acquire the undertaking in Trinidad and Tobago of Premier Oil plc. formerly known as Premier Consolidated Oilfields PLC (hereinafter referred to as "PCO") a company incorporated in Scotland:

And whereas it is expedient to vest the undertaking of PCO in PREMIER in the manner hereinafter set forth:

Enactment ENACTED by the Parliament of Trinidad and Tobago as follows:—

Short title 1. This Act may be cited as the Premier Vesting Act, 1997.

Interpretation 2. In this Act—

“appointed day” means the day on which this Act comes into operation under section 7;

“undertaking” means all assets, liabilities, rights and obligations of PCO in Trinidad and Tobago including but not limited to those set out in the Schedule hereto.

Schedule

Vesting of Undertaking 3. (1) The undertaking is hereby transferred to and vested in PREMIER, to the intent that PREMIER shall succeed to the undertaking as if in all respects PREMIER were the same person in law as PCO.

(2) No transfer or vesting effected by virtue of this Act shall—

(a) operate as a breach of covenant or conditions against alienation;

(b) give rise to any forfeiture;

(c) invalidate or discharge any contract or security;

(d) operate so as to merge any leasehold interest in the reversion expectant in it.

4. (1) Subject to section 3, the effect of the vesting of ^{Effect of Vesting} the undertaking shall be that from the appointed day—

(a) every contract existing before the appointed day to which PCO was a party except those entirely relating to any assets to be retained by PCO whether in writing or not, shall be construed and have effect as if—

- (i) PREMIER is a party instead of PCO;
- (ii) for any reference to PCO whether express or implied, there were substituted as respect anything falling to be done on or after the appointed day, a reference to PREMIER;
- (iii) any reference, whether express or implied, to the director or to any director, officer, clerk or servant of PCO were, as respect anything falling to be done on or after the appointed day, a reference, as the case may be, to the director of PREMIER or to such director, officer, clerk or servant of PREMIER as it may appoint or, in default of appointment, to the director, officer, clerk or servant of PREMIER who corresponds as nearly as may be to any such director, officer, clerk or servant of PCO;

(b) all collective agreements within the meaning of the Industrial Relations Act, or ^{Chap. 88:01} any replacement or modification thereof in existence before the appointed day, to which PCO was a party shall be construed

and have effect as if PREMIER were a party thereto and for the purposes of such agreements and of that Act, PREMIER shall be deemed to be the successor to PCO;

- (c) notwithstanding the Income Tax Act, or any other law to the contrary, any contract to which paragraph (a) applies and which before the appointed day is an approved plan, fund or scheme under the said Income Tax Act, shall, after the appointed day, continue to be treated as an approved plan, fund or scheme for the purposes of the Income Tax Act;
- (d) any account between PCO and any other party shall become an account between PREMIER and that other party;
- (e) any instruction, direction, mandate, power of attorney or consent given to or by PCO and in existence before the appointed day shall have effect as if given to or by PREMIER;
- (f) any negotiable instrument or order for payment of money, which is expressed to be drawn on or given to or accepted or endorsed by PCO or payable to PCO, shall have effect as if it had been drawn on or given to or accepted or endorsed by PREMIER or payable to PREMIER;
- (g) any security transferred to PREMIER that before the appointed day was held by PCO as security for the payment or discharge of a debt or liability or obligation, whether present or future, actual or contingent shall be held by and be available to PREMIER as security for the payment or discharge of that debt or liability or obligation, and any such security which

- extends to future advances or liabilities shall on and from the appointed day, be held by and be available to PREMIER as security for future advances by, and future liabilities to PCO in the same manner in all respects as future advances by or liabilities to PCO were secured thereby immediately before the appointed day;
- (h) any security provided by or for PCO that before the appointed day was held as security for the payment or discharge by PCO of a debt or liability or obligation, whether present or future, actual or contingent, shall be held by and be available to a holder as security for the payment or discharge by PREMIER of that debt or liability or obligation, and any security which extends to future advances or liabilities shall on and from the appointed day, be held by and be available to the holder as security for future advances to and future liabilities of PREMIER in the same manner and in all respects as future advances to or liabilities of PCO were secured thereby immediately before the appointed day;
- (i) any judgment or award obtained by or against PCO and not fully satisfied shall be enforceable by or against PREMIER;
- (j) an officer, clerk or servant employed by PCO before the appointed day shall, unless he terminates his employment, become an officer, clerk or servant, as the case may be, of PREMIER on terms and conditions no less favourable than those on which he was so employed immediately before the appointed day and employment with PCO and PREMIER respectively shall be deemed for all purposes to be single

continuing employment, save that no director, secretary or auditor of PCO shall by reason only of this Act become a director, secretary or auditor, as the case may be, of PREMIER;

(2) Subsection (1)(a)(ii) applies to any statutory instrument, to any contract in existence before the appointed day to which PCO was not a party and to any other document as it applies in relation to a contract to which subsection (1)(a) applies.

5. Within sixty days after the coming into force of this Act PREMIER shall pay to the Government of Trinidad and Tobago such Stamp Duties and Registration Fees as may be adjudicated by the Board of Inland Revenue and the Registrar General of Trinidad and Tobago on the same basis as if the acquisition of the freehold and leasehold property set forth in the Schedule hereto forming part of the undertaking or any part thereof were done by conveyance or assignment.

6. Nothing in this Act shall affect or be deemed to affect the rights of the State, or of any bodies politic or corporate or of any person, except such as are mentioned in this Act, and those claiming by, through, from or under them.

7. This Act shall be deemed to have come into operation on the day of , 1997.

SCHEDULE

PART I

PROPERTY AND RIGHTS TRANSFERRED

The right, title, claim or interest of PCO in all property, rights and other things of every kind, real or personal, moveable and immovable, corporeal or incorporeal in possession or in action comprising all the assets of the exploration, production, manufacturing and marketing business of PCO as appears in the final balance sheet and are recorded in its books as at the appointed day.

Subject to the foregoing these shall include but shall not be limited to:

- (1) The freehold property set forth in Appendix "A".
- (2) All oil mining leases and licences and freehold petroleum rights including working rights held by PCO and in particular those set forth in Appendix "B".
- (3) All producing and non-producing oilfields, inclusive of all wells (hydrocarbon or water), tank farms, gathering stations and all associated equipment, machinery and interconnecting piping, pipelines in the said fields and the relevant real estate and residential housing for the operation of the aforesaid fields.
