REPUBLIC OF TRINIDAD AND TOBAGO

THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE  
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS  
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to, CURTIS ISAAC also known as “DONKEY” also known as “ROAD” of No. 170 7th Avenue, North Malick, Morvant, also residing at Poinsettia Drive, Morvant, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said CURTIS ISAAC also known as “DONKEY” also known as “ROAD” of No. 170 7th Avenue, North Malick, Morvant, also residing at Poinsettia Drive, Morvant, shall be detained at the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima, or such other place as I may from time to time direct as the place where the said CURTIS ISAAC also known as “DONKEY” also

known as “ROAD” of No. 170 7th Avenue, North Malick, Morvant, also residing at Poinsettia Drive, Morvant, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, CURTIS ISAAC also known as “DONKEY” also known as “ROAD” has been credibly identified as an active member, foot soldier, and armed enforcer for an Organised Crime Group (‘OCG’) within the definition of the Anti-Gang Act, 2021, known as the “Seven Gang” (7 Gang), operating out of the 7th Avenue, Malick. The OCG has access to firearms and ammunition and is actively engaged in a state of heightened, escalating gang warfare against rival factions in the Morvant policing district, causing a drastic uptick in violent murders. The detainee operates as an armed “shooter” and enforcer for the OCG with specific responsibilities to protect gang turf, conduct mobile armed patrols in enemy territory, and eliminate rival gang members on sight. Confidential intelligence and investigations reveal that the detainee was actively executing standing operational orders from the OCG’s leadership to remain armed and conduct mobile patrols in rival territory following the murder of a prominent gang member, Jamal Carter alias “Big Joe”. The detainee and others intend to imminently escalate these violent public assaults, posing an immediate, lethal threat to the public and law enforcement personnel, presenting a high probability of witness intimidation and interference with ongoing investigations if released.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2026, is necessary to disrupt these plans, prevent retaliatory violence, and prevent him from acting in a manner prejudicial to public safety of Trinidad and Tobago.
