THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to KUROON MOHAMMED also known as “NAZ KUROON MOHAMMED” also known as “KAY” also known as “DIAZ UTRA” also known as “KURMON” of Jayrasingh Road, Coalmine, Sangre Grande and also of No. 7 Jasper Avenue, Greenvale, La Horquetta and also of No. 206 Eastern Main Road, Valencia, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said KUROON MOHAMMED also known as “NAZ KUROON MOHAMMED” also known as “KAY” also known as “DIAZ UTRA” also known as “KURMON” of Jayrasingh Road,

Coalmine, Sangre Grande and also of No. 7 Jasper Avenue, Greenvale, La Horquetta and also of No. 206 Eastern Main Road, Valencia, shall be detained at the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima, or such other place as I may from time to time direct, as the place where the said KUROON MOHAMMED also known as “NAZ KUROON MOHAMMED” also known as “KAY” also known as “DIAZ UTRA” also known as “KURMON” of Jayrasingh Road, Coalmine, Sangre Grande and also of No. 7 Jasper Avenue, Greenvale, La Horquetta and also of No. 206 Eastern Main Road, Valencia, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, KUROON MOHAMMED also known as “NAZ KUROON MOHAMMED” also known as “KAY” also known as “DIAZ UTRA” also known as “KURMON” has been credibly identified through confidential intelligence as a member of an Organised Crime Group (‘OCG’) within the meaning of the Anti-Gang Act, 2021. The OCG is engaged in the theft and supply of motor vehicles for use by other OCGs in the commission of criminal offenses including murders, shooting, retaliatory attacks, armed home invasions, trafficking of illegal narcotics, firearms, ammunition and persons and for scrapping and sale of parts. Confidential intelligence links the detainee to a recent larceny of a motor vehicle at Trincity Mall. Further intelligence indicates that the detainee and others intend to imminently escalate their theft and supply of stolen vehicles to other OCGs for gang related activities which are prejudicial to public safety.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2026, is necessary to disrupt these plans and prevent him from acting in a manner prejudicial to public safety.
