THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to JOSHUA CORBIN also known as “JMAN” of Unity Trace, Edna Hill, Arouca and also of K2 Terres, Edna Hill, Arouca and also of Ballantyne Road, Five Rivers, Arouca, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, hereby order that the said JOSHUA CORBIN also known as “JMAN” of Unity Trace, Edna Hill, Arouca and also of K2 Terres, Edna Hill,

Arouca and also of Ballantyne Road, Five Rivers, Arouca, shall be detained at the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima, or such other place as I may from time to time direct, as the place where the said JOSHUA CORBIN also known as “JMAN” of Unity Trace, Edna Hill, Arouca and also of K2 Terres, Edna Hill, Arouca and also of Ballantyne Road, Five Rivers, Arouca, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, JOSHUA CORBIN also known as “JMAN” has been credibly identified as a principal member of an organised crime group engaged in the theft and dismantling of stolen motor vehicles and the disposal of stolen vehicle parts. Intelligence identifies the detainee as being directly involved in the scrapping of stolen vehicles, including motor vehicle registration number PEF 5049, and in the recovery of vehicle components at locations associated with members of the Resistance Gang faction operating in the Arouca district. Intelligence further identifies the detainee as a main shooter for the Resistance Gang and links him to robberies and illegal firearms activity within the district. The detainee has been assessed by confidential intelligence as participating in organised criminal activity which supports the operations of a gang associated with violent offending and as intending, together with his associates, to commit violent and serious crimes in the near future.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2026, is necessary to disrupt these plans and prevent him from acting in a manner prejudicial to public safety.
