MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(CARIBBEAN PREMIER LEAGUE T20) (NO. 2) ORDER, 2026

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Caribbean Premier League T20) (No. 2) Order, 2026.

2. This Order has effect during the following periods: Duration

- (a) from 4.00 p.m. on Wednesday 26th August, 2026, to 1.00 a.m. on Thursday 27th August, 2026;
- (b) from 5.00 p.m. on Friday 28th August, 2026, to 2.00 a.m. on Saturday 29th August, 2026;
- (c) from 4.00 p.m. on Saturday 29th August, 2026, to 1.00 a.m. on Sunday 30th August, 2026;
- (d) from 2.00 p.m. to 11.00 p.m. on Monday 31st August, 2026; and
- (e) from 4.00 p.m. on Wednesday 2nd September, 2026, to 1.00 a.m. on Thursday 3rd September, 2026.

3. Parking is prohibited on—

- (a) Tragarete Road, between Broome Street and Gray Street;
- (b) St. Clair Avenue, between Broome Street and Gray Street; and
- (c) Sweet Briar Road, between Alexandra Street and Gray Street.

4. Driving and parking of a motor vehicle are prohibited on—

- (a) Elizabeth Street, between St. Clair Avenue and Tragarete Road;
- (b) Sweet Briar Road, between Elizabeth Street and Alexandra Street;
- (c) Havelock Street, between Tragarete Road and St. Clair Avenue.

5. Without prejudice to any liability incurred by the commission of a traffic violation, a motor vehicle found parked in contravention of this Order may be removed, impounded and dealt with in accordance with sections 108 and 109 of the Motor Vehicles and Road Traffic Act.
