REPUBLIC OF TRINIDAD AND TOBAGO

Act No. 39 of 1981

**AN ACT to amend the Judges Salaries and Pensions Act,
1965**

[Assented to 18th September, 1981]

ENACTED by the Parliament of Trinidad and Tobago as **Enactment**
follows:—

1. This Act may be cited as the **Judges Salaries and Pensions (Amendment) Act, 1981**, Short title

2. Section 4 of the Judges Salaries and Pensions Act, 1965 is amended as follows—

(a) by renumbering the section as section 4(1);

(b) by repealing and replacing the subsection as renumbered as follows—

“ 4. (1) There shall be paid—

(a) to the Chief Justice of
Trinidad and Tobago—

(i) for the year
1977 a salary
of sixty-four
thousand,
eight hundred
and ninety-six
dollars;

(ii) for the year
1978 a salary
of sixty-eight
thousand, one
hundred and
thirty-six
dollars;

(iii) for the year
1979 a salary
of seventy-one
thousand, five
hundred and
forty-four
dollars;

(iv) for the year
1980 a salary
of seventy-
eight thou-
sand, six
hundred and
ninety-six
dollars;

(b) to every Judge of the
Court of Appeal—

(i) for the year
1977 a salary
of fifty-six

seven hundred
a n d e i g h t y -
four dollars;

(ii) for the year
1978 a salary
o f f i f t y - n i n e
thousand, six
hundred and
twenty - eight
dollars;

(iii) for the year
1979 a salary
o f s i x t y - t w o

four dollars;

(iv) for the year
1980 a salary
o f s i x t y - e i g h t
t h o u s a n d,
eight hundred
a n d s i x t y -
eight dollars;

(c) to every Judge of the
High Court—

(i) for the year
1977 a salary
o f f i f t y t h o u -
s a n d , s e v e n
h u n d r e d
dollars;

(ii) for the year
1978 a salary
o f f i f t y - t h r e e
thousand, two
hundred and
t h i r t y - t w o
dollars;

(iii) for the year 1979 a salary of fifty-five thousand, eight hundred and ninety-six dollars;

(iv) for the year 1980 a salary of sixty-one thousand, four hundred and eighty-eight dollars;

(c) by adding a new subsection as follows—

“ (2) There shall be paid—

(a) to the Chief Justice of Trinidad and Tobago a salary of one hundred and eight thousand dollars a year;

(b) to every Judge of the Court of Appeal, a salary of ninety thousand dollars a year;

(c) to every Judge of the High Court, a salary of seventy-eight thousand dollars a year.”.

Commencement

3. (1) Paragraphs (a) and (b) of section 2 shall be deemed to have come into operation on the 1st day of January, 1977.

(2) Paragraph (c) of section 2 shall be deemed to have come into force on the 1st day of January, 1981.
