PRIVATE BURIAL GROUND

NOTICE is hereby given that His Excellency the Governor, in exercise of the powers vested in him by the Burial Grounds Ordinance, Ch. 12. No. 18 has, with the advice of the Executive Council, licensed as a Private Burial Ground solely for the burial of Roman Catholic dead the parcel of land described in the Schedule hereunder.

That parcel of land containing one rood and twenty-five perches, more or less, situate about 200 feet West of the junction of the Eastern Main and Cunapo Roads, and about 330 feet measured in a south-westerly direction from the southern side of the Eastern Main Road, in the Ward of Turure, in the County of St. Andrew, forming part of the property belonging now or formerly to Frederick Clive Urich and Agatha Exley Urich, and more particularly shown and delineated and coloured raw sienna on a plan filed at folio 229 in Book 859 in the Lands and Surveys Vault, Red House, and bounded as follows:—

North—by lands of the Archbishop of Port-of-Spain.

South—by lands of Agatha and F. C. Urich formerly J. H. Martin and lands of H. P. de Souza now Sylvano Alfonso.

East —by lands of the Archbishop of Port-of-Spain and lands of H. P. de Souza now Sylvano Alfonso.

West —by lands of Agatha and F. C. Urich formerly J. H. Martin.

CONTROL OF IMPORTS AND EXPORTS

FOOD PRICES ORDER No. 2 OF 1954

In exercise of the powers conferred on the Controller of Imports and Exports by virtue of the Supplies and Services (Transitional Powers) Order, 1945 and the Emergency Laws (Miscellaneous Provisions) Order, 1951, and all other powers hereunto him enabling, the following Order is hereby made:—

1. This Order shall come into operation and take effect from the 6th day of March, 1954.

2. Part I of the Schedule to the Price of Goods Regulations, 1945, as from time to time amended is hereby further amended by:—

deleting all the words, figures and symbols occurring in the columns opposite the article "Meat (Frozen)—Beef—Kidneys, Rumps, Scotch Fillets—Other Cuts: (a) Silversides, Topsides, Thickflank, Rounds—(b) Blade and Bolar, Clods, Shins, Briskets; Lamb—Other Cuts; Pork—Head and Feet, Other Cuts and substituting therefor the following:—
