Made by the Transport Board under section 65 of the Motor Vehicles and Road Traffic Act

THE TRAFFIC CONTROL ORDER, 1986

1. This Order may be cited as the Traffic Control Order, 1986.

Citation

PART I-MARAVAL

- 2. Parking is prohibited except on Sundays and Public Holidays on the Parking following roads—
 - (a) Saddle Road, between Pois Casse to the South and Perseverance Road to the North; and
 - (b) Morne Coco Road, between Saddle Road and Saut d'Eau Road.
 - 3. Between 6.00 a.m. and 9.00 a.m. Mondays to Fridays, vehicular traffic—One-way traffic
 - (a) shall proceed in a westerly direction on Camille Drive, between Saddle Road and Coco Road;
 - (b) may not turn from Saddle Road into—
 - (i) Darcey Road; or
 - (ii) Valerie Road.

PART II—ST. CLAIR

- 4. Vehicular traffic shall proceed—
 - (a) in a northerly direction on Newbold Street, between Saddle Road One-way and Scott Street;
 - (b) in a westerly direction on Serpentine Road, between Maraval Road and Mary Street;
 - (c) from 6.00 a.m. to 9.00 a.m. and 3.00 p.m. to 9.00 p.m., in a westerly direction on Rapsey Street between Saddle Road and Wainwright Street;
 - (d) in a clockwise direction only on Rookery Nook from 6.00 a.m. to 9.00 a.m., Mondays to Fridays.
- 5. Vehicular traffic proceeding North along Newbold Street shall not No right turn right into Saddle Road.

PART III-ST. JAMES

6. Parking is prohibited on the Western Main Road—

(i) on the eastern side on Mondays, Wednesdays and

Fridays; and

(ii) on the western side on Tuesdays, Thursdays and Saturdays;

(h) on Clarence Street-

(i) on the eastern side on Mondays, Wednesdays and

Fridays; and

(ii) on the western side on Tuesdays, Thursdays and Saturdays;

(i) on Vidale Street-

(i) on the eastern side on Mondays, Wednesdays and

Fridays; and

(ii) on the western side on Tuesdays, Thursdays and Saturdays;

(j) on Dengue Street—

(i) on the eastern side on Mondays, Wednesdays and

Fridays; and

(ii) on the western side on Tuesdays, Thursdays and Saturdays.

Vehicular traffic shall not stop or park on—

- (a) the Western Main Road within fifty metres of its junction with No stopping or parking either George Cabral Street or Long Circular Road;
- (b) George Cabral Street within thirty metres of its junction with the Western Main Road;
- (c) Luckput Street within thirty metres of its junction with the Western Main Road; or
- (d) Long Circular Road within fifty metres of its junction with the Western Main Road.

9. Vehicular traffic shall proceed—

- (a) in a southerly direction on Link Road and Coronation Street;
- (b) in an easterly direction on Carlton Avenue, between Mucurapo Road and Luckput Street;
- (c) in a northerly direction on Luckput Street;
- (d) in a southerly direction on Cawnpore Street, between the Western Main Road and Hyderabad Street;
- (e) in a northerly direction on Nepaul Street, between the Western Main Road and Hyderabad Street;
- (f) in a southerly direction on Nizam Street, between the Western Main Road and Panka Street;
- (g) in a northerly direction on Clarence Street, between the Western Main Road and Panka Street;
- (h) in a southerly direction on Vidale Street, between the Western Main Road and Panka Street;
- (i) in a northerly direction on Dengue Street, between the Western Main Road and Finland Street; and
- (j) in a southerly direction on Ethel Street, between the Western Main Road and Panka Street.
- 10. Vehicular traffic leaving Luckput Street shall not enter George Cabral No straight Street at the intersection of Western Main Road and George Cabral Street,

11. At the intersection of—

(a) Panka Street and Bay Road, Bay Road is the major road and changes to Panka Street is the minor road;

major roads and minor

- (b) Coronation Street and Carlton Avenue, Carlton Avenue is the roads major road and Coronation Street is the minor road; and
- (c) George Cabral Street and Kathleen Street, George Cabral Street is the major road and Kathleen Street is the minor road.
- 12. The Western Main Road, between Jeffers Street and Damian Street, Four-lane shall be operated as a dual-carriageway with two lanes in each carriageway. carriageway

13. Parking is prohibited on—

- (a) the northern and southern carriageways of Wrightson Road;
- (b) French Street, between Wrightson Road and McDonald Street;

- (e) Henry Street, between Independence Square South and Park Street, except on Sundays and Public Holidays;
- (f) Queen Street, between Chacon Street and Abercromby Street;
- (g) Duke Street, between Nelson Street and Victoria Square East, except on Sundays and Public Holidays;
- (h) Charlotte Street, between Park Street and Independence Square South, except on Sundays and Public Holidays;
- (i) Gordon Street, between Dundonald Street and Charlotte Street, except on Sundays and Public Holidays;
- (j) Tragarete Road, between Damian Street and Edward Street on Mondays to Fridays, between 6.00 a.m. and 9.00 a.m. and 3.00 p.m. and 6.00 p.m.;
- (k) Tragarete Road, between St. Vincent Street and Edward Street (except that taxis plying for hire may park facing West in the taxi-stand on the southern side);
- (1) Ariapita Avenue on Mondays to Fridays from 6.00 a.m. to 9.00 a.m. and 3.00 p.m. to 6.00 p.m.;
- (m) Park Street, between Scott Bushe Street and Victoria Square West;
- (n) Park Street, between Richmond Street and St. Vincent Street, (except that taxis plying for hire, may park facing East on the northern side of the taxi-stand between Edward Street and St. Vincent Street);
- (o) Richmond Street, between Tragarete Road and Park Street;
- (p) Edward Street, between Park Street and Tragarete Road;
- (q) the eastern side of George Street, between Duke Street and Prince Street;
- (r) Sackville Street, between Richmond Street and St. Vincent Street;
- (s) Piccadilly Street, between Besson Street and St. Joseph Road;
- (t) the southern side of Besson Street;
- (u) New Street, between Henry Street and Charlotte Street;
- (v) Chacon Street, between Independence Square North and Independence Square South;
- (w) the western side of Abercromby Street, between Independence Square South and Queen Street;
- (x) St. Joseph Road, between Plaisance Road and St. Ann's River;
- (y) the northern side of Independence Square South, between Chacon Street and Abercromby Street;
- (z) St. Vincent Street, between Independence Square South and South Quay;
- (aa) Edward Street, between Independence Square South and Wrightson Road;
- (bb) Ajax Street from Wrightson Road, extending northwards for a distance of one hundred and fifty metres; and
- (cc) Ajax Street from a point one hundred and fifty metres from Wrightson Road—the western side only.

14. Parking is permitted—

Parking restricted

- (a) on the eastern side of Gatacre Street, between Wrightson Road and Ariapita Avenue;
- (b) on the eastern side of Charles Street Extension, between Charles Street and Wrightson Road;
- (c) subject to regulation 13(j), on Tragarete Road, between Damian Street and Edward Street—
 - (i) on the southern side on Mondays, Wednesdays and Fridays;
 - (ii) on the northern side on Tuesdays, Thursdays, Saturdays and Sundays;
- (d) on Stone Street—
 - (i) on the eastern side on Mondays, Wednesdays and Fridays; and
 - (ii) on the western side on Tuesdays, Thursdays and Saturdays;
- (e) on the northern side of Fraser Street;
- (f) on the southern side of Duke Street, between Melbourne Street and Shine Street;
- (g) on the southern side of New Street, between Dundonald Street and Pembroke Street;
- (h) on the southern side of New Street, between Frederick Street and Henry Street.

15. Vehicular traffic shall not stop or park—

No stopping or parking

- (a) on Tragarete Road, within thirty metres of the junction of that road with—
 - (i) French Street;
 - (ii) Cipriani Boulevard; or
 - (iii) Dundonald Street;
- (b) on Ariapita Avenue, within thirty metres of the junction of that road with—
 - (i) Ana Street;
 - (ii) Carlos Street;
 - (iii) French Street; or
 - (iv) Colville Street;
- (c) within fifty metres of all approaches to and exits from the intersection of Richmond Street and Park Street, except for buses stopping at bus stops;
- (d) within thirty metres of all approaches to and exits from the intersection of Park Street and St. Vincent Street, except for taxis at the taxi-stands.
- 16. Vehicular traffic shall proceed—
 - (a) in a westerly direction on Duke Street, between Nelson Street and One-way George Street;
 - (b) in a southerly direction on Piccadilly Street, between Park Street/ Bath Street and Duke Street;
 - (c) in an easterly direction on Besson Street, between St. Joseph Road and Piccadilly Street;

- (d) in a southerly direction on French Street, between Ariapita Avenue and Wrightson Road;
- (e) in a northerly direction on Colville Street, between Wrightson Road and Ariapita Avenue;
- (f) in a westerly direction on Duke Street, between Richmond Street and Victoria Square West;
- (g) in a northerly direction on Stone Street, between Duke Street and Charles Street;
- (h) in a westerly direction on Charles Street;
- (i) in a northerly direction on Charles Street Extension between Charles Street and the point at which Sackville Street and Wr.ghtson Road meet;
- (j) in a westerly direction on Tragarete Road, between St. Vincent Street and Edward Street;
- (k) in an easterly direction on Park Street, between Victoria Square West and the point at which Piccadilly Street and Bath Street meet;
- (l) in a southerly direction on Victoria Square East;
- (m) in a southerly direction on Richmond Street;
- (n) in a northerly direction on Victoria Square West;
- (o) in an easterly direction on Fraser Street; and
- (p) in a westerly direction on Kew Place, between Park Street and Longden Street.

Two-way tra**ttic**

- 17. Vehicular traffic may proceed in both directions between Wrightson Road and Ariapita Avenue on the following roads—
 - (a) Gallus Street;
 - (b) Alberto Street;
 - (c) Luis Street;
 - (d) Alfredo Street;
 - (e) Fitt Street;
 - (f) Cornelio Street;
 - (g) Gatacre Street; and
 - (h) Murray Street.

No right turn

- 18. Vehicular traffic proceeding-
 - (a) East along Gordon Street may not turn right into Charlotte Street;
 - (b) along Wrightson Road, may not turn right through the following median openings:—
 - (i) Wrightson Road and French Street; or
 - (ii) Wrightson Road and Dock Road.

No "U" turn

- 19. (1) Vehicular traffic may not turn through median openings so as to face the opposite direction to that in which they were proceeding at the intersection of—
 - (a) Wrightson Road and French Street;
 - (b) Wrightson Road and Edward Street;

- (c) Wrightson Road and Colville Street;
- (d) Wrightson Road and Independence Square; or
- (e) South Quay and Abercromby Street.
- (2) Vehicular traffic proceeding along Wrightson Road may turn through the median opening at the intersection of Sackville Street.
- 20. Vehicular traffic proceeding South along Ajax Street shall turn left Left turn Ajax Street into Wrightson Road.
 - 21. Vehicular traffic shall give way to traffic on the right—

Give way to vehicles on the right

- (a) when turning left into Wrightson Road from Dock Road;
- (b) when turning left into Wrightson Road from the Port Authority entrance; and
- (c) when turning left into the Port Authority entrance from the Beetham Highway.
- 22. The intersections of Wrightson Road with the roads listed in clause 19 Intersections closed are closed.
 - 23. The following roads are four-lane two-way roads—

Four-lane roads

- (a) Tragarete Road, from Damian Street to White Street; and
- (b) Ariapita Avenue, from Maraval Parkway to Park Street.
- 24. Westbound traffic in the right lane on Wrightson Road between Right lane-Wrightson South Quay and Edward Street, shall turn into Edward Street.

Road and Edward Street

25. Vehicular traffic proceeding in an easterny unrection only along opening—Wrightson Road may turn right through the median opening at Duke Street. Duke Street and Wright-

26 All median openings on Wrightson Road between Ana Street and Median South Quay, not mentioned in these Regulations are closed to vehicular traffic.

opening— Wrightson Road closed

Taxis may park as follows—

- (a) fifteen taxis plying the St. Ann's route may park facing West in Taxi-stands the taxi-stand on the southern side of Hart Street, from a point nine metres from Frederick Street extending in a westerly direction;
- (b) one large maxi-taxi or two small maxi-taxis may park parallel to each other North of the "on call" taxi-stand on the western side of Cipriani Statue on Independence Square North;
- (c) forty maxi-taxis plying the eastern routes may park facing North between the yellow lines drawn on the surface of Broadway, between Independence Square South and South Quay;
- (d) both taxis and maxi-taxis plying the Maraval route may park on the western side of George Street, between Duke Street and Prince Street, in the following manner-
 - (i) ten taxis tacing North, from a point nine metres from Duke Street extending southwards for a distance of fifty-five metres; and three taxis facing north extending southwards for a further thirteen metres, but separated from the above-mentioned ten taxis by a distance of three metres; and

- (ii) ten maxi-taxis facing North, from a point nine metres from Prince Street extending northwards for a distance of fifty-five metres;
- (e) twenty-five taxis plying the Curepe-Tunapuna route may park racing West in the taxi-stand on the southern side of South Quay, from a point nine metres from Broadway extending in an easterly direction;
- (f) twenty-five taxis plying the Arima-Sangre Grande route may park in the taxi-stand on the southern side of South Quay, from a point nine metres from Charlotte Street extending eastwards to a point nine metres before the entrance to the Bus Terminus;
- (g) twenty-five taxis plying the St. James route may park in the taxi-stand on the northern side of Hart Street, from a point nine metres from Abercromby Street extending eastwards;
- (h) thirty taxis plying the San Juan and Morvant routes may park facing East in the taxi-stand on the northern side of South Quay between Charlotte Street and Nelson Street.

Parking for private cars only

- 28. (1) In this clause "parking area" means the area bounded as follows—
 - (a) on the North by South Quay;
 - (b) on the South by Beetham Highway;
 - (c) on the East by Central Marketing Agency; and
 - (d) on the West by Wrightson Road.
 - (2) Parking in the parking area is reserved for private cars only.
- (3) Private cars may be parked only in the parking spaces between the white lines drawn on the surface of the parking area and only in such a manner as would not obstruct free entry to or exit from the parking area.

PART V-BARATARIA/MORVANT

One-way

29. Between 6.00 a.m. and 9.00 a.m. Mondays to Fridays, vehicular traffic shall proceed on Park Street, between Ramirez Street and Lady Young Road—in an easterly direction only.

Parking prohibited

- 30. Parking is prohibited on-
 - (a) Seventh Avenue, between Eastern Main Road and Second Street;
 - (b) the northern side of Seventh Street, from its western end to its junction with Tenth Avenue;
 - (c) Fifth Street, from Seventh Avenue to Fifth Avenue; and
 - (d) Sixth Avenue from Seventh Street to Fifth Street.

Parking permitted

- 31. Parking is permitted on—
 - (a) the southern side of Sixth Street, between Sixth Avenue and Fifth Avenue;
 - (b) the northern side of Sixth Street, between Seventh Avenue and Sixth Avenue; and
 - (c) the eastern side of Tenth Avenue, between Fifth Street and Ninth Street.

One-way traffic

- 32. Vehicular traffic shall proceed—
 - (a) in an easterly direction on Fifth Street, between Churchill-Roosevelt Highway and Tenth Avenue;

- (b) in an easterly direction on Sixth Street, between Seventh Avenue and Fifth Avenue;
- (c) in a westerly direction on Seventh Street, between Fifth Avenue and Seventh Avenue;
- (d) in a southerly direction on Fifth Avenue, between Fifth Street and Seventh Street; and
- (e) in a southerly direction on Seventh Avenue, between Fifth Street and Sixth Street.
- 33. Vehicular traffic shall not turn from Fifth Street into Sixth Avenue. No turn
- 34. (1) Vehicular traffic proceeding East along Fifth Street may gain Access from access to—
 - (a) Sixth Avenue, by turning right into Seventh Avenue and then left into Sixth Street; and
 - (b) Eastern Main Road, by turning left into El Socorro Road.
- (2) Vehicular traffic proceeding West along Fifth Street may gain access to—
 - (a) Sixth Avenue, by turning left into Fifth Avenue and right into Seventh Street; and
 - (b) Churchill-Roosevelt Highway, by turning left into Tenth Avenue.

- 35. Parking is prohibited on—
 - (a) Saddle Road, between Mission Road and Eastern Main Road; Parking prohibited

 - (e) Prizgar Road, between Saddle Road and Newalloville Extension Avenue;
 - (f) Newalloville Extension Avenue, between Mission Road and Prizgar Road;
 - (g) Real Street, between Saddle Road and Santa Cruz Old Road;
 - (h) Ryan Street, between Eastern Main Road and St. Joseph Street;
 - (i) Bridge Road;
 - (j) Maloney Street;
 - (k) Martin Trace, between El Socorro Road and Don Miguel Road;
 - (1) Eastern Main Road, between Saddle Road and Aranguez Road; and
 - (m) Fifth Street, between El Socorro Road and Don Miguel Road.
- 36. Vehicular traffic shall not stop or park on the following roads—

No stopping or parking Load

- (a) Eastern Main Road, from a point fifty metres West of Saddle Road to a point fifty metres East of Aranguez Road;
- (b) the eastern side of El Socorro Road, between Back Chain Street and Railway Road; and
- (c) the western side of El Socorro Road, between Bissessar Street and Fifth Street.

Parking restricted

- 37. Parking is permitted on the Aranguez Main Road as follows—
 - (a) on the eastern side on Mondays, Wednesdays and Fridays; and
 - (b) on the western side on Tuesdays, Thursdays and Saturdays.

One-way

- 38. Vehicular traffic shall proceed—
 - (a) in a westward and northward direction on Bridge Road, between Savannah Road and Neverson Street;
 - (b) in a southerly direction on Aranguez Road, between the Eastern Main Road and the point at which Railway Road meets Fifth Street:
 - (c) in a westerly direction on Neverson Street, between Bridge Road and Savannah Road;
 - (d) in a southerly direction on Savannah Road, between Neverson Street and Bridge Road;
 - (e) in a westerly direction on Maloney Street, between Eastern Main Road and Byatt Street;
 - (f) in a northerly direction on Saddle Road, between Prizgar Road and Mission Road;
 - (g) in a southerly direction on Newalloville Extension Avenue, between Prizgar Road and Mission Road;
 - (h) in an easterly direction on Prizgar Road, between Newalloville Extension Avenue and Saddle Road;
 - (i) in a southerly direction on El Socorro Road, between Back Chain Street and Fifth Street; and
 - (j) in a westerly direction on Martin Trace, between El Socorro Road and Don Miguel Road.

No right turn

- 39. Vehicular traffic proceeding West—
 - (a) along Real Street, shall not turn right into Saddle Road; and
 - (b) along Maloney Street, shall not turn right into Bridge Road.

No left turn

Road closed

41. Vehicular traffic proceeding East or West along the Eastern Main Road may not enter Bridge Road.

Taxi-stand El Socorro

- 42. (1) Twenty-five taxis plying the El Socorro-Aranguez routes may park facing East in the taxi-stand on the northern side of Railway Road, the most westerly part of the stand being at the junction of El Socorro Road and Railway Road.
- (2) Fifteen taxis plying the Highway route may park facing West on the southern side of Fifth Street, from a point nine metres West of El Socorro Road extending westwards.
- (3) Fifteen taxis plying the El Socorro-Aranguez routes may park facing West on the southern side of Railway Road, from a point nine metres East of El Socorro Road extending eastwards.

- 43. Parking is prohibited on—

 - (c) in a southerly direction on Fairley Street, between Green Street and the Eastern Main Road;
 - (d) in a northerly direction on Cochrane Street.

Intersection closed
