MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE
MINISTER UNDER SECTION 67(1) OF THE MOTOR VEHICLES AND
ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)
(ARIMA) REGULATIONS, 1998

1. These Regulations may be cited as the Traffic Control Citation
(Experimental Scheme) (Arima) Regulations, 1998.
2. These Regulations shall have effect from Friday, 6th March, 1998 to Saturday, 6th June, 1998. Commence-
ment and
cessation
3. Maxi-taxis plying for hire shall park as follows: Maxi-taxi
stands
 - (a) Green Band maxi-taxis shall park along the southern side of De Verteuil Street facing west;
 - (b) Red Band maxi-taxis operating along Eastern Main Road shall park along the western side of St. Joseph Street, between Farfan Street and Broadway, facing north;
 - (c) Red Band maxi-taxis operating along the Priority Bus Route shall park along the eastern side of St. Joseph Street, between Sanchez Street and Broadway facing south;
 - (d) Sangre Grande maxi-taxis shall park along the eastern side of Raglan Street facing south.
4. Maxi-taxis may ply for hire as follows: Maxi-taxi
routes
 - (a) Maxi-taxis operating along the San Rafael route shall—
 - (i) when approaching Arima, proceed north along Tumpuna Road, west into Quesnel Street, north into Pro De Verteuil Street, then west into De Verteuil Street and into the stand;
 - (ii) when leaving the stand, proceed south along Pro Queen Street, east along Malabar Road, continuing south along the said Malabar Road, east along Malabar Branch Road and then south into Tumpuna Road to their destination;

(b) maxi-taxis operating along the Caparo route shall—

- (i) when approaching Arima, proceed north along O'Meara Road, east into La Chance Trace, north into Subero Street, east into Koon Koon Street, north into Malabar Road, continuing north into Nelson Street, north east along Quesnel Street, west into Pro De Verteuil Street and into the stand;
- (ii) when leaving the stand proceed south along Pro Queen Street and south into O'Meara Road;

(c) maxi-taxis operating along the Priority Bus Route shall—

- (i) when approaching Arima, proceed east along Hollis Avenue, north into St. Joseph Street, west along Green Street, north along King Street, east along Sanchez Street and into the stand on St. Joseph Street;
- (ii) when leaving the stand, proceed west along Broadway, south along King Street, west along Anglican Street, south along Industry Street and west along John Shaw Avenue;

(d) maxi-taxis operating along the Sangre Grande route shall—

- (i) when approaching Arima, proceed west along Eastern Main Road, north into Moreno Street, north-west into Columbus Street, west along Sorzano Street, south into Raglan Street and into the stand;
- (ii) when leaving the stand, proceed east along Guanapo Street, continuing east along Eastern Main Road;

(e) maxi-taxis operating along the Main Road shall—

- (i) when approaching Arima, proceed east along Hollis Avenue, north into St. Joseph Street and into the maxi-taxi stand;
- (ii) when leaving the stand, proceed west along Broadway, south into King Street, west into Anglican Street, south into Industry Street, and west along John Shaw Avenue.

Roads closed
to maxi-taxis

5. The following roads are closed to maxi-taxis as follows:

- (a) O'Meara Road, between La Chance Trace and the Priority Bus Route, in the case of Green Band maxi-taxis;
- (b) De Verteuil Street, between Llanos Street and Pro Queen Street, in the case of Red Band maxi-taxis;

- (c) Hollis Avenue, between St. Joseph Street and Queen Street;
- (d) Woodford Street, between Sanchez Street and Sorzano Street;
- (e) Queen Street, between Sanchez Street and Broadway;
- (f) Sorzano Street, between King Street and Prince Street;
- (g) Guanapo Street, between Moreno Street and Raglan Street;
- (h) Green Street, between King Street and Cocorite Street;
- (i) Rawl Circular, between King Street and Gordon Street;
- (j) Farfan Street, between St. Joseph Street and Woodford Street;
- (k) Quesnel Street, between Nelson Street and Pro Queen Street;
- (l) Malabar Road, between Nelson Street and Pro Queen Street;
- (m) Rose Street, between St. Joseph Street and King Street;
- (n) King Street, between Hollis Avenue and Anglican Street;
- (o) Broadway, between Raglan Street and King Street;
- (p) Cocorite Street, between Quesnel Street and Broadway;
- (q) Maurice Avenue, between Guanapo Street and Cocorite Street.

6. Vehicles shall not stop or wait on—

No stopping
or waiting

- (a) Hollis Avenue, between Industry Street and Queen Street;
- (b) Queen Street, between Sorzano Street and Green Street;
- (c) the southern side of Broadway, between Woodford Street and King Street.

7. Parking is prohibited on—

Parking
prohibited

- (a) Queen Street, between Sorzano Street and Hollis Avenue;
- (b) Pro Queen Street, between Hollis Avenue and Railway Road;
- (c) the southern side of Farfan Street, between Cocorite Street and Queen Street;
- (d) the northern side of Farfan Street, between Queen Street and St. Joseph Street;
- (e) Green Street, between Queen Street and King Street;
- (f) the northern side of Green Street, between Queen Street and Cocorite Street;

- (g) the eastern side of Woodford Street, between Broadway and Sanchez Street;
- (h) the eastern side of Prince Street, between Broadway and Sorzano Street;
- (i) Woodford Street, between Hollis Avenue and Broadway;
- (j) Railway Road, between Pro Queen Street and Robinson Circular;
- (k) Robinson Circular, from Pro Queen Street to Railway Road;
- (l) Queen Mary Avenue, between Robinson Circular and Hollis Avenue;
- (m) Sorzano Street, between King Street and Columbus Street;
- (n) King Street, between Sanchez Street and Hollis Avenue;
- (o) Anglican Street, between King Street and Industry Street;
- (p) Industry Street, between Anglican Street and Hollis Avenue;
- (q) Queen Street, between Sanchez Street and Hollis Avenue;
- (r) Guanapo Street, between Raglan Street and Quesnel Street;
- (s) the western side of Raglan Street, between Sorzano Street and Broadway;
- (t) Broadway, between Queen Street and Woodford Street;
- (u) the northern side of De Verteuil Street, between Llanos Street and Pro Queen Street;
- (v) the eastern side of St. Joseph Street, between Hollis Avenue and Broadway;
- (w) the western side of St. Joseph Street, between Sanchez Street and Broadway;
- (x) the southern side of Devenish Street, between Queen Street and Cocorite Street.

No left turn

8. Vehicular traffic proceeding—

- (a) along Malabar Road, shall not turn left into Nelson Street;
- (b) east along Sanchez Street, shall not turn left into St. Joseph Street.

Taxi stands

9. Taxis plying for hire shall park as follows:

- (a) taxis operating along the Arima to Port-of-Spain route, shall park on the northern side of Broadway, facing west, between Woodford Street and St. Joseph Street;
- (b) taxis operating along the Mausica Old Road route, shall park on the western side of St. Joseph Street, facing north, between Hollis Avenue and Farfan Street;

- (c) taxis operating along the Caparo O'Meara Road route, shall park on the northern side of Devenish Street, facing east, between Queen Street and Cocorite Street;
- (d) taxis operating along the Malabar route, shall park on the western side of Pro Queen Street, facing south, between the entrance to the Arima Market and Loubon Street;
- (e) taxis operating along the Calvary Hill route, shall park on the western side of Woodford Street, facing north, between Broadway and Sorzano Street;
- (f) taxis operating along the Brazil/Talparo route, shall park on the northern side of Farfan Street, facing west, between Cocorite Street and Queen Street;
- (g) taxis operating along the Cocorite/La Horquetta route, shall park on the southern side of Green Street, facing east, between Queen Street and Cocorite Street;
- (h) taxis operating along the Mt. Pleasant route, shall park on the western side of Prince Street, facing north, between Broadway and Sorzano Street;
- (i) taxis operating along the Pinto Road route, shall park on the southern side of Broadway, facing west, between Jodoo's Book Store and Queen Street;
- (j) taxis operating along the Sangre Grande to Valencia route, shall park on the northern side of Broadway, facing east, between Queen Street and Ideal Store;
- (k) taxis operating along the Cumuto to Waller Field route, shall park on the northern side of Broadway, facing east, between Ideal Store and Republic Bank.

10. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations, may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
