# REPUBLIC OF TRINIDAD AND TOBAGO

## The Motor Vehicles and Road Traffic (Enforcement and Administration) Act, 1978

### REGULATIONS

Made by the President under section 12 of the Motor Vehicles and Road Traffic (Enforcement and Administration) Act

## THE MOTOR VEHICLES AND ROAD TRAFFIC (FIXED PENALTY) (AMENDMENT) REGULATIONS, 1984

1. These Regulations may be cited as the Motor Vehicles and Road <sup>Citation</sup> Traffic (Fixed Penalty) (Amendment) Regulations, 1984.

2. The Motor Vehicles and Road Traffic (Fixed Penalty) Regulations are amended—

- (a) in regulation 4 by inserting immediately after the words
  "police station" in line three of subregulation (2), the words "or the Licensing Office or the District Revenue Office";
- (b) in regulation 5 by repealing and replacing paragraph (b) as follows—
  - "(b) immediately after his return to the station or office to which he is attached, submit a copy of the notice to the officer in charge of that station or office, to be kept there for the purpose of record;";
- (c) in regulation 6 by inserting immediately after the word "Inspector" appearing in line four thereof the words "or the Transport Commissioner";
- (d) in regulation  $7^{--}$ 
  - (i) by repealing and replacing subregulation (1) as follows—

"(1)(a) Payment of a fixed penalty may be made personally or through an agent, and shall be accompanied by the notice.

(b) Where the alleged offender is not in possession of the notice and paragraph (a) cannot be fully complied with, the person liable to pay the fixed penalty shall appear personally to make the payment.";

(ii) by repealing subregulation (4) and replacing it as follows—

" (4) In this regulation "Clerk" includes the Transport Commissioner and the District Revenue Officer.";

- (e) in regulation 8 by inserting immediately after the word "Clerk" appearing in line one thereof, the words "Transport Commissioner or District Revenue Officer";
- (f) in regulation 9-
  - (i) by deleting the words "received by the Clerk", appearing in line one thereof and by substituting for them the word "made";
  - (ii) by removing the symbol ";" appearing after the word "Police" in line three of paragraph (a) and by including after the same word "Police" the words and symbol "or the Transport Commissioner as may be necessary;";
  - (iii) by removing the symbol "." appearing in the last line of paragraph (b) thereof and by including after the word "Police" in the last line of this paragraph the words "or the Transport Commissioner as may be necessary.";
- (g) in regulation 10-
  - (i) by deleting the figure (1) appearing immediately before the word "The" in the first line of this regulation;
  - (ii) by substituting for the word "shall" appearing in the first line of this regulation the word "is";
  - (iii) by inserting immediately after the word "payment" appearing in the second line of this regulation the words "summoned to.";
  - (iv) by deleting subregulation (2) thereof;
- (h) by adding a new regulation as follows—

"Assignment of estate constables 11. For the purposes of these Regulations an estate constable shall be assigned to a police station in such a division as the Commissioner of Police may determine.":

(i) by replacing the existing Schedule with a new Schedule as follows—

If this amount is paid to the Clerk of the Peace within fourteen (14) days from the date of the notice, no proceedings will be taken and any liability to conviction for the offence will be discharged.

In paying the fixed penalty the following conditions shall be observed:

- (1) The fixed penalty shall be accompanied by this Notice.
- (2) Where payment of the fixed penalty is not made in conformity with the regulations, the payment shall be returned to the alleged offender and, thereafter, proceedings against him shall begin.
- (3) Payment of the fixed penalty shall be made or remitted to the Clerk of the Peace at
  - (a) The Office of the Clerk of the Peace
