THE CIVIL SERVICE ACT, CHAP. 23:01

REGULATIONS

MADE BY THE MINISTER UNDER SECTION 28 OF THE CIVIL SERVICE ACT

THE PUBLIC HEALTH INSPECTORS (CIVIL SERVICE) (OVERTIME ALLOWANCE) (AMENDMENT) REGULATIONS, 2005

1. These Regulations may be cited as the Public Health Inspectors _{Citation} (Civil Service) (Overtime Allowance) (Amendment) Regulations, 2005.

2. In these Regulations "the Regulations" means the Public Health Interpretation Inspectors (Civil Service) (Overtime Allowance) Regulations, 1992.

3. The Regulations are amended—

Regulations amended

- (a) in regulation 2 in the definition of "Public Health" Inspector", by inserting after the words "Ministry of Health", the words "and the Tobago House of Assembly";
- (b) in regulation 3(1)(b) by deleting the words "rate of \$40.24 per hour for the first eight hours of overtime and \$53.65 per hour thereafter" and substituting the words "rate of \$45.51 per hour for the first eight hours of overtime and \$60.68 per hour thereafter";
- (c) by inserting a new regulation 3A as follows:

" 3A. (1) Every person who requires the services of a Public Health Inspector during his normal working hours or in excess of his normal working hours for the inspection of—

- (a) vessels, ships, aircraft; or
- (b) meat at "private" slaughter houses approved under the Slaughter Houses (Rural Districts) Bye Laws, 1957,

shall—

- (i) apply for his services to the Medical Officer of Health in the relevant application form set out in the Schedule;
- (ii) pay to the Medical Officer of Health a fee at the rate of \$45.51 per hour for the time worked during his normal working hours and for the first eight hours of overtime and \$60.68 per hour thereafter;

- (iii) pay for or provide suitable transportation, as is required by the Medical Officer of Health in respect of a Public Health Inspector to and from the location of the vessel, ship, aircraft or private slaughter house where there is no Public Health Inspector permanently stationed at the site of such cargo; and
- (iv) pay any reasonable charge claimed by the Medical Officer of Health in respect of a meal allowance of a Public Health Inspector.

(2) All charges claimed by the Medical Officer of Health shall be set out on the prescribed form in the Schedule.

(3) A Public Health Inspector performing overtime work as required under this regulation shall be paid an overtime allowance for his services at the rate of \$41.37 per hour for the first eight hours of overtime and \$55.16 per hour thereafter and a meal allowance for which he qualifies at the rate and under the conditions applicable to eligible public officers.".

4. The Regulations are amended in regulation 4 by deleting the words "due to him and an overtime allowance for his services at the rate of \$36.59 per hour for the first eight hours of overtime and \$48.78 per hour thereafter" and substituting the words "at the rate applicable to eligible public officers and an overtime allowance for his services at the rate of \$41.37 per hour for the first eight hours of overtime and \$55.16 per hour thereafter.".

- 5. The Regulations are amended in the Schedule-
 - (a) in Form 1 by-
 - (i) inserting after the words "MINISTRY OF HEALTH" the words "/TOBAGO HOUSE OF ASSEMBLY";
 - (ii) inserting after the word "Container(s)" wherever it occurs the words "/vessels/ships/aircraft/"private" slaughter houses";
 - (iii) inserting after the words "Consignee/Agent", the words "/Service Requestor";
 - (iv) deleting the words "at \$40.24 per hour" and substituting the words "at \$45.51 per hour"; and
 - (v) deleting the words "at \$53.65 per hour" and substituting the words "at \$60.68 per hour";

Schedule amended (b) in Form 2 by-

- (i) inserting after the words "MINISTRY OF HEALTH" the words "/TOBAGO HOUSE OF ASSEMBLY";
- (ii) inserting after the word "Container(s)" wherever it occurs the words "/vessels/ships/aircraft/"private" slaughter houses";
- (iii) deleting the words "at \$40.24 per hour" and substituting the words "at \$45.51 per hour"; and
- (iv) deleting the words "at \$53.65 per hour" and substituting the words "at \$60.68 per hour".

6. These Regulations are deemed to have come into effect on $_{\text{Commence-1st}}$ January, 1996, except regulation 3(c) which introduces a new $^{\text{ment}}$ regulation 3A.
