MADE BY THE PRESIDENT UNDER SECTION 3 OF THE  
CIVIL SERVICE ACT, 1965THE CIVIL SERVICE (VARIATION OF THE FIRST SCHEDULE)  
(NO. 5) ORDER, 1977
