REPUBLIC OF TRINIDAD AND TOBAGO

Act No. 25 of 1982

AN ACT to amend the Tobago House of Assembly Act,
1980.

[Assented to 1st September, 1982]

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows—

1. This Act may be cited as the Tobago House of Short title
Assembly (Amendment) Act, 1982.

Section 2 of
Act No. 37 of
1980 amended

2. The Tobago House of Assembly Act, 1980 (hereinafter referred to as "the Act") is amended in section 2 by inserting in the appropriate alphabetical order the following definitions—

"Minister of Finance" means the Minister to whom responsibility for finance is assigned;

"statutory authority" has the meaning assigned to it in the Statutory Authorities Act."

Section 4(1) of
the Act amended

3. The Act is amended in section 4(1) by inserting between the words "member" and "and" occurring in line two, the word "if".

Section 15 of
the Act amended

4. The Act is amended in section 15 by substituting for the word "Council" occurring in line two, the word "Assembly".

Section 40 of
the Act amended

5. Section 40 of the Act is amended—

(a) by repealing subsection (2); and

(b) by renumbering subsection (1) as section 40.

Section 41 of
the Act amended

6. Section 41 of the Act is amended by deleting the words "and employees" occurring in line one.

The Act amended

7. The Act is amended by inserting immediately after section 42 the following new section—

"Transfer of employees of the former Council to the Assembly" 42A. (1) Persons who, immediately before the commencement of this Act, were daily-rated workers of the former Council are hereby transferred to the Assembly."

(2) The Chief Personnel Officer shall appoint, remove, transfer and exercise disciplinary control over the daily-rated workers of the assembly and in respect of any such worker, is deemed to be his employer for the purposes of the Industrial Relations Act.

Section 44 of
the Act amended

8. Section 44 of the Act is amended by repealing subsection (4).

9. Section 59 of the Act is amended by substituting ^{Section 59 of} ~~the Act amended~~ for the words "a member of the Cabinet" occurring in lines seven and eight, the words "the Minister".

10. The Act is amended in the Fourth Schedule by ^{Fourth Schedule} ~~of the Act~~ substituting for the words "Section 59" appearing in ^{amended} brackets in the heading, the words "Section 60".

11. This Act is deemed to have come into operation ^{Commencement} on the 23rd September, 1980.
