MADE BY THE GOVERNOR UNDER SECTION 15 OF THE TRINIDAD AND TOBAGO
(CONSTITUTION) ORDER IN COUNCIL, 1961

THE DIRECTOR OF PUBLIC PROSECUTIONS ADAPTATION
ORDER, 1961

1. This Order may be cited as the Director of Public Prosecutions Adaptation Order, 1961.
2. A reference to the Attorney General in the Ordinances enumerated in the first column of the Schedule to this Order shall be read and construed as a reference to the Director of Public Prosecutions in the provisions of those Ordinances set out in the second column of the said Schedule.
3. The reference in subsection (1) of section 34 of the Judicature Ordinance to the Attorney General shall be read and construed as a reference to the Director of Public Prosecutions where the application is made in respect of criminal proceedings. Ch. 3. No. 1.
4. Section 19 of the Jury Ordinance shall be read and construed without reference to the Solicitor General. Ch. 4. No. 2.
5. The Law Officers Ordinance shall be read and construed— Ch. 7. No. 3.
 - (a) without the words "criminal or" in the second line of section 4 thereof, and
 - (b) as though section 5 thereof had been deleted.
6. Section 13 of the Services (Charges Control) Ordinance shall be read and construed as though the words "the Director of Public Prosecutions" were substituted for the words "one of the Law Officers specified in Part I of the Schedule to the Law Officers Ordinance." Ch. 30. No. 18.
7. This Order shall have effect from the day Part IV of the Constitution of Trinidad and Tobago comes into force.
