NOTICE OF FINAL ACTION IN RESPECT OF THE
ENVIRONMENTALLY SENSITIVE AREAS RULES, 2001

Issued under section 29 of the Environmental Management Act

NOTICE is hereby given that the Environmentally Sensitive Areas Rules, 2001 (“the ESA Rules”) was made on the 13th day of February, 2001, published as Legal Notice No. 37 of 2001, laid in the House of Representatives on the 2nd day of March, 2001 and in the Senate on the 13th day of March, 2001.
