NOTICE OF SUBMISSION FOR PUBLIC COMMENT ON  
REISSUE TO CERTIFICATE OF ENVIRONMENTAL  
CLEARANCE NO. CEC1248/2005

NOTICE is hereby given that Essar Steel Caribbean Limited and the Environmental Management Authority are desirous of amending condition (iv)(f) in Certificate of Environmental Clearance No. CEC1248/2005 issued to Essar Steel Caribbean Limited involving the establishment of an Iron and Steel Complex at the proposed Point Lisas Extension Industrial Estate and that pursuant to EAP 001 of 2007 intituled between Essar Steel Caribbean Limited and the Environmental Management Authority a Consent Order dated February 14, 2007 has been filed with the Environmental Commission.

And take notice that the Environmental Management Authority (“the Authority”) has, pursuant to the Consent Order filed before the Environmental Commission on February 14, 2007 established an Administrative Record that includes a copy of the proposed Order, a written description of the proposed action, the major environmental issues involved in the matter under consideration and copies of relevant documents and other supporting materials which the Authority believes would assist the public in developing a reasonable understanding of those issues and a statement of the Authority’s reasons for the proposed action.

And take notice that the comments of the public are hereby invited on the proposed amendment to the Certificate of Environmental Clearance and that any person wishing to submit comments must do so in writing addressed to the Corporate Secretary, Environmental Management Authority, 8, Elizabeth Street, St. Clair, Port-of-Spain, from Wednesday 28th February, 2007 to Thursday 29th March, 2007.
