REPUBLIC OF TRINIDAD AND TOBAGO

Act No. 51 of 1977

[L.S.]

AN ACT to provide for the Service of Trinidad and Tobago for the year ending on the 31st day of December, 1978.

[Assented to 19th December, 1977]

ENACTED by the Parliament of Trinidad and Tobago as Enactment follows:—

1. This Act may be cited as the Appropriation Act, Short title 1978.

Issue of
\$3,133,884,895
from Consolidated
Fund authorised

2. The issue from the Consolidated Fund of the sum of three thousand one hundred and thirty-three million, eight hundred and eighty-four thousand, eight hundred and ninety-five dollars is hereby authorised for meeting expenditure for the service of the year ending 31st December, 1978, under the Heads of Expenditure specified in the Schedule; and the sum specified in the Schedule opposite to a Head is hereby appropriated out of the said sum of three thousand one hundred and thirty-three million, eight hundred and eighty-four thousand, eight hundred and ninety-five dollars for the purposes specified in relation to that Head in the Estimates for the said year.

Commencement

3. This Act shall come into force on the 1st day of January, 1978.
