AN ACT to provide for the Service of Trinidad and Tobago
for the year ending on the 31st day of December, 1985.

[Assented to 25th January, 1985]

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:—

1. This Act may be cited as the Appropriation Act, 1985. Short title

2. The issue from the Consolidated Fund of the sum of eight thousand, eight hundred and ninety-seven million, two hundred and seventy thousand, six hundred and seventy-nine dollars is hereby authorised for meeting expenditure for the service of the year ending 31st December, 1985 under the Heads of Expenditure specified in the Schedule; and the sum specified in the Schedule opposite to a Head is hereby appropriated out of the said sum of eight thousand, eight hundred and ninety-seven million, two hundred and seventy thousand, six hundred and seventy-nine dollars for the purposes specified in relation to that Head in the Estimates for the said year.

Commencement

3. This Act shall be deemed to have come into force on the 1st day of January, 1985.
