REPUBLIC OF TRINIDAD AND TOBAGO

**Act No. 29 of 1980**

[L.S.]

AN ACT to provide for the supplementary appropriation  
for the service of Trinidad and Tobago for the year  
ending on the 31st day of December, 1980.

*[Assented to 16th June, 1980]*

ENACTED by the Parliament of Trinidad and Tobago as Enactment  
follows:—

1. This Act may be cited as the Supplementary Short title  
Appropriation Act, 1980.

2. A further issue from the Consolidated Fund of the sum of six hundred million, six hundred and three thousand, three hundred and twelve dollars is hereby authorised for meeting expenditure for the service of the year ending 31st December, 1980, under the Heads of Expenditure specified in the Schedule; and the sum specified in the Schedule opposite a Head of Expenditure is hereby appropriated out of the six hundred million, six hundred and three thousand, three hundred and twelve dollars for the purposes specified in relation to that Head in Supplementary Estimates for 1980.
