REPUBLIC OF TRINIDAD AND TOBAGO

Act No. 29 of 1993

[L.S.]

AN ACT to provide for the service of Trinidad and Tobago for the year ending on the 31st day of December, 1994.

[Assented to 16th December, 1993]

ENACTED by the Parliament of Trinidad and Tobago as Enactment follows:—

1. This Act may be cited as the Appropriation Act, Short title 1994.

2. The issue from the Consolidated Fund of the sum of ten thousand, one hundred million, two hundred and forty-seven thousand, five hundred and seventy-eight dollars is hereby authorised for meeting expenditure for the service of the year ending 31st December, 1994 under the Heads of Expenditure specified in the Schedule; and the sum specified in the Schedule opposite to a Head is hereby appropriated out of the said sum of ten thousand, one hundred million, two hundred and forty-seven thousand, five hundred and seventy-eight dollars for the purpose specified in relation to that Head in the Estimates for the said year.

Commencement

3. This Act shall come into force on the 1st day of January, 1994.
