Act No. 23 of 1990

An Act to provide for the service of Trinidad and Tobago
for the year ending on the 31st day of December, 1991.

[Assented to 27th December, 1990]

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:—

1. This Act may be cited as the Appropriation Act, 1991. Short title

2. The issue from the Consolidated Fund of the sum of seven thousand, two hundred and forty-one million, seven hundred and fifty-four thousand, one hundred and ninety-one dollars is hereby authorised for meeting expenditure for the service of the year ending 31st December, 1991 under the Heads of Expenditure specified in the Schedule and the sum specified in the Schedule opposite to a Head is hereby appropriated out of the said sum of seven thousand two hundred and forty-one million, seven hundred and fifty-four thousand, one hundred and ninety-one dollars for the purpose specified in relation to that Head in the Estimates for the said year.

Commencement

3. This Act shall come into force on the 1st day of January, 1991.
