Act No. 23 of 2007

AN ACT to provide for the Service of Trinidad and
Tobago for the financial year ending on the 30th day
of September, 2008

[Assented to 7th September, 2007]

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:—

1. This Act may be cited as the Short title Appropriation
Act, 2008.

Issue from the
Consolidated Fund
authorized

2. (1) The issue from the Consolidated Fund of the sum of thirty-six thousand, four hundred and seventy-seven million, one hundred and eighty-eight thousand, one hundred and fifteen dollars (\$36,477,188,115) is authorized for meeting expenditure for the service of the financial year ending on the 30th day of September, 2008, under the Heads of Expenditure specified in the First Column of the Schedule.

Schedule

(2) The sum specified in the Second Column of the Schedule, in relation to the Head of Expenditure specified in the First Column of the Schedule, is appropriated out of the sum of thirty-six thousand, four hundred and seventy-seven million, one hundred and eighty-eight thousand, one hundred and fifteen dollars (\$36,477,188,115) for the financial year ending on the 30th day of September, 2008.

Commencement

3. This Act shall come into force on the 1st day of October, 2007.
