AN ORDINANCE to make provision for defraying the Expenses of the Government of the Island of Trinidad for the year 1896.

BE it enacted by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof as follows:—

There may be issued and paid from and out of the Public Monies of the Island of Trinidad for the Service of the year one thousand eight hundred and ninety-six an amount not exceeding the following sums, that is to say:—
