BE it enacted by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof as follows :—

1. There may be issued and paid from and out of the Public Moneys of the Island of Trinidad for the Service of the Year One Thousand Eight Hundred and Ninety-three an amount not exceeding the following Sums—that is to say :

3. This Ordinance shall not extend to Tobago.
