TRINIDAD AND TOBAGO

Act No. 30 of 1969

AN ACT for the Incorporation of the Christadelphian Bible Mission (Trinidad and Tobago).

[Assented to 30th September, 1969]

WHEREAS there has been established in Trinidad and Tobago a religious, charitable and social association known as the Christadelphian Bible Mission (Trinidad and Tobago).

And whereas it is expedient that the said association should be incorporated under the name of the Christadelphian Bible Mission (Trinidad and Tobago) for the purpose of exercising the powers hereinafter set forth.

Enactment

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and House of Representatives of Trinidad and Tobago, and by the authority of the same as follows:—

Short title

1. This Act may be cited as the Christadelphian Bible Mission (Trinidad and Tobago) Incorporation Act, 1969.

2. The Association known as the Christadelphian Bible Mission (Trinidad and Tobago), hereinafter referred to as "The Mission" is hereby created a body corporate and by that name shall have perpetual succession, and may sue and be sued in all Courts of Justice in Trinidad and Tobago by that name, and shall have and use a common Seal with power from time to time to change such Seal.

3. The Mission shall have power:

- (a) to acquire by purchase, transfer, donation, exchange, devise, bequest, grant, gift, conveyance or however otherwise, any real or personal property or any estate or interest therein;
- (b) to accept surrenders or re-conveyances and to enter into contracts;
- (c) subject to any restraint, reservation or condition contained in the document under which it shall have acquired title thereto, to sell, exchange, demise, mortgage, or otherwise dispose of and deal with all property which may for the time being be vested in or have been acquired by it.

4. All documents requiring the Seal of the Mission shall be sealed with its common Seal in the presence of two of the members of the Committee of the Mission for the time being in office who shall both sign every such document, and such signing shall be prima facie evidence that the said Seal was duly affixed and that the same is the lawful Seal of the Mission.

5. The Mission shall at all times have a fixed address in Trinidad and Tobago for the service of documents on the Mission and such address shall be registered with the Registrar General. All documents to be served on the Mission may be served by leaving the same at, or by sending the same by registered post to, the address so registered.

6. All lands and other property of what nature so ever now vested in any person for the use of the members of the Mission are hereby transferred to and vested in the Mission.

7. Nothing in this Act shall affect the rights of Her Majesty, Her Heirs or Successors or of any bodies politic or corporate or of any other persons except such as are mentioned in this Act and those claiming by, from or under them.
