NOTIFICATION

INTENTION TO MAKE A NOTICE DESIGNATING MATURA  
NATIONAL PARK AS AN ENVIRONMENTALLY SENSITIVE  
AREA

IT IS HEREBY NOTIFIED that the Environmental Management Authority in exercise of the power granted to it by section 41 of the Environmental Management Act, 2000 (“the Act”) proposes to make a notice designating Matura National Park as an Environmentally Sensitive Area (“the Proposed Notice”).

And take notice that the Environmental Management Authority (“the Authority”) pursuant to rule 5(4) of the Environmentally Sensitive Areas Rules, 2001 (“the Rules”), now invites submissions from the public with respect to the Proposed Notice and pursuant to rule 5(6) of the Rules, such submissions shall contain the grounds therefor and may include additions, modifications or amendments to give effect to the submissions.
