NOTICE is hereby given that Atlantic LNG Company of Trinidad and Tobago is desirous of executing a new project to establish coastal defence structures at Guapo Bay, Point Fortin and this project would involve the stabilization and protection of the slope immediately east of the Clifton Hill seawall, to provide protection for approximately 1200 m of the Guapo Bay shoreline, as well as to provide erosion control measures for the adjacent gas pipelines and to widen and upgrade a section of the Guapo Beach and that this project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order, 2001, thus requiring a Certificate of Environmental Clearance ("the Certificate") pursuant to section 35 of the Environmental Management Act, 2000 ("the Act").
