NOTICE is hereby given, that Vision City Company Limited is desirous of executing a new project, involving the clearing and grading of 13-35 hectares of land (and associated works) to facilitate the establishment of a Commercial Business Centre inclusive of a Shopping Mall, Hotel, Apartment Development, Sewage Treatment Plant and other related facilities, Off Toco Main Road, Sangre Grande and that this project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order, 2001, thus requiring a Certificate of Environmental Clearance (“the Certificate”) pursuant to section 35 of the Environmental Management Act, 2000 (“the Act”).

And take notice that the Environmental Management Authority (“the Authority”) has, for the purposes of the Certificate and pursuant to section 28(1)(b) of the Act, established an Administrative Record that includes a written description of the proposed action, the major environmental issues involved in the matter under consideration, copies of relevant documents or other supporting materials which the Authority believes would assist the public in developing a reasonable understanding of those issues and a statement of the Authority’s reasons for the proposed action.
