NOTICE OF SUBMISSION FOR PUBLIC COMMENT ON AN
APPLICATION FOR A CERTIFICATE OF ENVIRONMENTAL
CLEARANCE WHICH REQUIRES AN ENVIRONMENTAL
IMPACT ASSESSMENT SUBMITTED BY CARIBBEAN GAS
CHEMICAL LIMITED

NOTICE is hereby given that Caribbean Gas Chemical Limited (CGCL) is desirous of establishing a Methanol plant, a Di-methyl-ether plant and a Desalination plant at the Union Industrial Estate, La Brea, and that this project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order (as amended), thus requiring a Certificate of Environmental Clearance pursuant to section 35 of the Environmental Management Act, Chap. 35:05 (“the Act”). CGCL has applied for a Certificate of Environmental Clearance (“the Certificate”) from the Environmental Management Authority (“the Authority”) for this project.

And take notice that the comments of the public are hereby invited on the application for the Certificate for the establishment of a Methanol plant, a Di-methyl-ether plant and a Desalination plant at the Union Industrial Estate, La Brea which requires an Environmental Impact Assessment.

And take notice that the Authority has, for the purposes of the Certificate and pursuant to section 28(1)(b) of the Act, established an Administrative Record that includes a written description of the proposed action, the major environmental issues involved in the matter under consideration, copies of relevant documents or other supporting materials which the Authority believes would assist the public in developing a reasonable understanding of those issues and of the Authority’s reasons for the proposed action.
