NOTICE OF SUBMISSION FOR PUBLIC COMMENT ON AN
ENVIRONMENTAL IMPACT ASSESSMENT REPORT
SUBMITTED BY THE NATIONAL GAS COMPANY OF
TRINIDAD AND TOBAGO LIMITED

NOTICE is hereby given that the National Gas Company of Trinidad and Tobago Limited is desirous of executing a new project involving the establishment of a 3.56 kilometre long, 152 mm (6-inch) diameter natural gas distribution pipeline commencing at the Mahaica Pipeline at Waller Field and terminating at Tamana e-Tech Park; and the upgrade of a 357 metre long, 50 mm (2-inch) diameter natural gas service pipeline commencing at York Avenue and ending at Unicell Paper Mills Caribbean Limited located within the O'Meara Industrial Estate in Arima and that this project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order, 2001, thus requiring a Certificate of Environmental Clearance ("the Certificate") pursuant to section 35 of the Environmental Management Act, 2000 ("the Act").

And take notice that the Environmental Management Authority ("the Authority") has, for the purposes of the Certificate and pursuant to section 28(1)(b) of the Act, established an Administrative Record that includes a written description of the proposed action, the major environmental issues involved in the matter under consideration, copies of relevant documents or other supporting materials which the Authority believes would assist the public in developing a reasonable understanding of those issues and a statement of the Authority's reasons for the proposed action.

And take notice that the Administrative Record is available to the public for viewing at the following offices from 8.00 a.m. to 4.00 p.m. Monday to Friday, from Monday 26th November, 2007 to Friday 28th December, 2007:

And take notice that the comments of the public are hereby invited on the Environmental Impact Assessment Report and that any person wishing to submit comments must do so in writing addressed to the Corporate Secretary, Environmental Management Authority, 8, Elizabeth Street, St. Clair, Port-of-Spain from Monday 26th November, 2007 to Friday 28th December, 2007.
