NOTICE is hereby given that the EOG Resources Trinidad Block 4(a)Unlimited is desirous of executing a new development project involving the installation of an offshore drilling and production platform, the drilling of six (6) development wells from the production platform and the establishment of a 29km 18-inch sub-sea pipeline within Concession Block 4(a), off the East Coast of Trinidad and that this project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order, 2001, as amended by Certificate of Environmental Clearance (Designated Activities) (Amendment) Order, 2007, thus requiring a Certificate of Environmental Clearance ("the Certificate") pursuant to section 35 of the Environmental Management Act, 2000 ("the Act").
