NOTICE OF SUBMISSION FOR PUBLIC COMMENT ON AN
ENVIRONMENTAL IMPACT ASSESSMENT REPORT
SUBMITTED BY EOG RESOURCES TRINIDAD LIMITED

NOTICE is hereby given that EOG Resources Trinidad Limited is desirous of executing a project in the South-East Coast Consortium (SECC) Block involving the drilling, completion and commissioning of three (3) additional development natural gas wells at the Pelican Platform, off the South-East Coast of Trinidad. This project is deemed a designated activity pursuant to the Certificate of Environmental Clearance (Designated Activities) Order, as amended, thus requiring a Certificate of Environmental Clearance (“the Certificate”) pursuant to section 35 of the Environmental Management Act (“the Act”).

And take notice that the Environmental Management Authority (“the Authority”) has, for the purpose of the Certificate and pursuant to section 28(1)(b) of the Act, established an Administrative Record that includes a written description of the proposed action, the major environmental issues involved in the matter under consideration, reasons for the proposed project, copies of relevant documents or other supporting materials which the Authority believes would assist the public in developing a reasonable understanding of those issues and a statement of the Authority’s reasons for the proposed action.

And take notice that the Administrative Record is available to the public for viewing at the following offices from 8.00 a.m. to 4.00 p.m., Monday to Friday, from Monday 10th August, 2009 to Friday 11th September, 2009:
