ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (LABOUR DAY CELEBRATIONS—FYZABAD) ORDER, 2015

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Labour Day Celebrations—Fyzabad) Order, 2015.
- 2. This Order has effect between the hours of 6.00 a.m. and Duration midnight on Friday 19th June, 2015.
 - 3. No person shall park a motor vehicle on-

No parking

- (a) Fyzabad-Guapo Road, between Uriah Butler Avenue and Gowers Well Road;
- (b) Easy Street, between Fyzabad-Guapo Road and Coolman Trace;
- (c) Coolman Trace, between Easy Street and Fyzabad-Guapo Road;
- (d) Fyzabad-Guapo Road, between Coolman Trace and Uriah Butler Avenue;
- (e) Lum Tack Hill;
- (f) Delhi Road, between John Jules Trace and Fyzabad-Oropouche Road;
- (g) Fyzabad-Oropouche Road, between Delhi Road and Monteil Trace;
- (h) Gowers Well Road, between Fyzabad-Guapo Road and John Jules Trace;
- (i) John Jules Trace, between Delhi Road and Gowers Well Road;
- (j) Uriah Butler Avenue, from the Dollar Value Supermarket to the Fyzabad Police Station;
- (k) Fyzabad-Oropouche Road, from Avocat Junction to Charlie King Junction;

- (1) Fyzabad-Oropouche Road, between Lum Tack Hill and Jimdar Street;
- (m) Siparia Old Road, between Avocat Junction and Samlal Trace, between the hours of 7.00 a.m. and midday; and
- (n) Fyzabad-Oropouche Road, between Avocat Junction and 200 metres north of Avocat Junction, between the hours of 7.00 a.m. and midday.

No vehicular traffic

4. No person shall drive a motor vehicle along Fyzabad-Guapo Road, between Uriah Butler Avenue and Charlie King Junction.

Vehicular traffic route

- 5. A person driving a motor vehicle and entering—
 - (a) Fyzabad from Oropouche, shall turn—
 - (i) left at Avocat Junction, onto Siparia Old Road, then onto Fyzabad-Guapo Road to the Fyzabad Composite School;
 - (ii) left at Ralph Narine Trace, left onto St. John Trace, left onto Avocat-Siparia Old Road at the Avocat Vedic School, then onto Fyzabad-Guapo Road to the Fyzabad Composite School; or
 - (iii) right onto Berridge Trace, left onto Mon Desir Road, left onto Delhi Road and onto Gowers Well Road;
 - (b) Oropouche from Fyzabad, shall proceed along Fyzabad-Guapo Road, turn left onto Siparia Old Road, right onto St. John Trace, left onto Ralph Narine Trace to Oropouche Main Road and right at Ralph Narine Trace Junction; and
 - (c) Siparia from—
 - (i) Fyzabad; and
 - (ii) Forest Reserve,

shall proceed in an easterly direction onto Uriah Butler Avenue and then onto Fyzabad-Guapo Road.

Emergency route

- 6. In an emergency, a person driving a motor vehicle and entering—
 - (a) San Fernando from Fyzabad, shall proceed along Delhi Road, onto Lutchman Drive, then onto Sewlal Trace via Fyzabad Main Road in Pepper Village; or
 - (b) Siparia from Fyzabad, shall proceed along Delhi Road, onto John Jules Trace, then onto Gowers Well Road, turn right onto Guapo Road—
 - (i) then turn left onto Sanderson Avenue (Butler Avenue); or

- (ii) proceed along Guapo Road and turn left onto Road No. 34, and proceed to Siparia Road.
- 7. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in impounding of contravention of this Order may be removed by the Police and unlawfully impounded and dealt with in accordance with section 108(1)(b) of the parked Motor Vehicles and Road Traffic Act.
