## ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

## THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (CEREMONIAL OPENING OF PARLIAMENT) ORDER, 2007

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Ceremonial Opening of Parliament) Order, 2007.
- 2. This Order has effect from 7.00 a.m. to 2.30 p.m. on Monday, Duration 17th December, 2007.
- 3. Motorists approaching the Red House for the Ceremonial Traffic Opening of Parliament shall do so by way of St. Vincent Street, Knox routes Street, Frederick Street, Hart Street and Abercromby Street.
- 4. (1) Motorists are prohibited from proceeding, from 9.00 a.m. to Vehicular 2.30 p.m. on—  $$^{\rm traffic}_{\rm prohibited}$$ 
  - (a) Abercromby Street, between Queen Street and Duke Street;
  - (b) Knox Street;
  - (c) Hart Street;
  - (d) St. Vincent Street, between Duke Street and Queen Street;
  - (e) Pembroke Street, between Duke Street and Knox Street; and
  - (f) Sackville Street, between Edward Street and St. Vincent Street.
  - (2) Subclause (1) shall not apply to a vehicle—
  - (a) of the President of the Senate;
  - (b) of the Speaker of the House;
  - (c) of Ministers of Government; and
  - (d) bearing green, blue, brown or red windscreen label.

Parking prohibited

- 5. Subject to clause 6, parking is prohibited from 7.00 a.m. to 2.30 p.m. on the following:
  - (a) Chancery Lane;
  - (b) Sackville Street, between Richmond Street and St. Vincent Street;
  - (c) Hart Street;
  - (d) Abercromby Street, between Queen Street and Keate Street;
  - (e) Keate Street, between Charlotte Street and Frederick Street;
  - (f) Frederick Street, between Keate Street and Hart Street;
  - (g) Gordon Street, between Chancery Lane and Abercromby Street;
  - (h) Knox Street, between St. Vincent Street and Frederick Street;
  - (i) St. Vincent Street, between Duke Street and Queen Street;
  - (j) Pembroke Street, between Knox Street and Duke Street; and
  - (k) Edward Street, between Queen Street and Duke Street.

Parking reserved

- 6. (1) The following persons:
  - (a) Members of the Diplomatic Corps;
  - (b) Heads of Religious Denominations; and
  - (c) Judges of the Supreme Court,

whose vehicles bear a brown windscreen label may park the vehicles on Knox Street, between Abercromby Street and Frederick Street.

- (2) The following persons:
- (a) the President of the Senate;
- (b) the Speaker of the House; and
- (c) Government Ministers,

whose vehicles bear a red windscreen label may park the vehicles on Knox Street, between Abercromby Street and Frederick Street.

- (3) A Member of Parliament other than a Minister of Government for whom parking is reserved under subclause (2)(c), and whose vehicle bears a blue windscreen label may park his vehicle on—
  - (a) St. Vincent Street, between Hart Street and Queen Street;

- (b) St. Vincent Street, between Knox and Sackville Streets;
- (c) Abercromby Street, between Hart Street and Queen Street.
- (4) A driver of a vehicle bearing a green windscreen label and who is a guest attending the Ceremonial Opening of Parliament may park the vehicle on the northern side of Hart Street, between Frederick Street and Abercromby Street.
- (5) A driver of a vehicle of the Trinidad and Tobago Regiment may park the vehicle on Edward Street, between Queen Street and Sackville Street.
- (6) A driver of a vehicle of the Trinidad and Tobago Police Service may park the vehicle on Edward Street, between Sackville Street and Duke Street.
- (7) A driver of a Justice On Time vehicle attached to the Port-of-Spain Magistrates' Court may park on the eastern side of St. Vincent Street, between Duke Street and Knox Street.

Taxi Stand

- 7. A driver of a taxi who plies for hire on—
  - (a) the St. Ann's route, from the taxi stand on Hart Street, shall operate from the southern side of Queen Street, between Frederick Street and Abercromby Street; and
  - (b) the St. James route, from the taxi stand on Hart Street, shall operate from the western side of Henry Street, between Prince Street and Duke Street.

8. Without prejudice to any other liability incurred by the impounding commission of a summary offence, vehicles found parked in unlawfully contravention of this Order may be removed by the Police and parked impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
