## ORDER

Made by the Commissioner of Police under Section 68(1) of the MOTOR VEHICLES AND ROAD TRAFFIC ACT

## THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (SIPARIA FETE) ORDER, 2006

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Fete) Order, 2006.
- 2. This Order has effect from 10.00 a.m. to 11.00 p.m. on Sunday Duration 7th May, 2006 and from 2.00 p.m. to 11.00 p.m. on Sunday 14th May, 2006.
- 3. Vehicles shall not be permitted to stop, wait or park on the Stopping, waiting and following: parking prohibited
  - (a) Grell Street;
  - (b) Gambal Street;
  - (c) Siparia Road, between High Street and Gambal Street;
  - (d) Victoria Street, between Allies Street and La Pastora
  - (e) Allies Street, between Bermudez Trace and Victoria Street;
  - (f) De Gannes Lane;
  - (g) La Pastora Street; and
  - (h) the northern side of Bermudez Trace.
- 4. (1) Vehicular traffic is prohibited between the hours of Vehicular 10.00 a.m. and 8.00 p.m. on Sunday 14th May, 2006 on the following: prohibited
  - (a) Allies Street, between High Street and Bermudez Trace;
  - (b) Daisy Voisin Street, between High Street and Victoria Street;
  - (c) Coora Road, between High Street and Victoria Street;
  - (d) Edward Street;
  - (e) High Street, between Grell Street and La Pastora Street;
  - (f) George Street;
  - (g) Mary Street; and
  - (h) Station Street, between Victoria Street and Mary Street.

(2) Vehicular traffic is prohibited between the hours of 10.00 a.m. and 1.00 p.m. on Sunday 7th May, 2006 on La Pastora Street.

Entry into Siparia

- 5. (1) Motorists entering Siparia from Penal shall proceed by way and exit from of Grell Street onto Gambal Street and onto Siparia Road.
  - (2) Motorists proceeding towards Penal from Siparia, shall proceed by way of Siparia Road, onto Gambal Street and onto Grell Street.

Diversion of traffic

- 6. (1) Motorists leaving Siparia from Mendez Village along Coora Road and proceeding to San Fernando, shall turn east onto Victoria Street, onto Allies Street, onto Bermudez Trace and east onto Siparia-Erin Road.
- (2) Motorists approaching Siparia from Mendez Village along Coora Road and proceeding to Erin, shall turn west onto Victoria Street, south onto Station Street and west onto Siparia-Erin Road.

Removal and impounding of vehicles unlawfully parked

7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
