Made by the Commissioner of Police with the approval of the Minister under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (HERITAGE ROOTS) ORDER, 2006

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Heritage Roots) Order, 2006.
- 2. This Order shall have effect from $6.00\ a.m.$ to $10.00\ p.m.$ on the Duration following days:
 - (a) Saturday 14th October, 2006;
 - (b) Sunday 15th October, 2006;
 - (c) Saturday 21st October, 2006;
 - (d) Sunday 22nd October, 2006;
 - (e) Saturday 28th October, 2006;
 - (f) Sunday 29th October, 2006;
 - (g) Saturday 4th November, 2006;
 - (h) Sunday 5th November, 2006;
 - (i) Saturday 11th November, 2006;
 - (j) Sunday 12th November, 2006;
 - (k) Saturday 18th November, 2006;
 - (1) Sunday 19th November, 2006;
 - (m) Saturday 25th November, 2006;
 - (n) Sunday 26th November, 2006;
 - (o) Saturday 2nd December, 2006;
 - (p) Sunday 3rd December, 2006;
 - (q) Saturday 9th December, 2006;
 - (r) Sunday 10th December, 2006;
 - (s) Saturday 16th December, 2006;
 - (t) Sunday 17th December, 2006;
 - (u) Saturday 23rd December, 2006;

- (v) Sunday 24th December, 2006;
- (w) Saturday 30th December, 2006;
- (x) Sunday 31st December, 2006.

Parking prohibited

3. (1) Parking is prohibited on the following roads:

- (a) Charlotte Street, between Park Street and Independence Square North;
- (b) Park Street;
- (c) Duke Street, between Frederick Street and Piccadilly Street;
- (d) Prince Street, between Frederick Street and Piccadilly Street;
- (e) Queen Street, between Frederick Street and Piccadilly Street;
- (f) Independence Square North;
- (g) Independence Square South;
- (h) Piccadilly Street;
- (i) Nelson Street, between Independence Square North and Duke Street;
- (j) Duncan Street, between Independence Square North and Prince Street;
- (k) George Street, between Independence Square North and Duke Street;
- (l) Henry Street, between Independence Square North and Park Street; and
- (m) Frederick Street, between Independence Square North and Park Street.

(2) Notwithstanding subclause (1)—

- (a) taxis plying the North Coast route (Maracas/Las Cuevas), shall park on the western side of George Street, between Prince Street and Duke Street;
- (b) taxis plying the Maraval route, shall park on the taxi stand on the southern side of Duke Street, between George and Charlotte Streets; and
- (c) taxis plying the Laventille route, shall park on the taxi stand on the western side of Nelson Street, between Duke and Prince Streets.

Road Closed 4. Vehicular traffic is prohibited on Charlotte Street, between Duke Street and Independence Square North.

Vehicular traffic 5. Vehicular traffic proceeding south along Charlotte Street, shall turn west onto Duke Street and then proceed to their respective destinations.

- 6. Taxis that ply the Belmont/Gonzales route from Charlotte Street, Taxi route shall operate from the southern side of Queen Street, between Nelson Street and Charlotte Street.
- 7. Without prejudice to any liability incurred by the commission of Removal and a summary offence, vehicles found parked in contravention of this impounding Order may be removed by the Police and impounded and dealt with in lawfully accordance with section 108(1)(b) of the Motor Vehicles and Road parked Traffic Act.
