## ORDER

Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

## THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (POINT FORTIN BOROUGH DAY CELEBRATIONS) ORDER, 2005

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Point Fortin Borough Day Celebrations) Order, 2005.
- 2. This Order has effect between the hours of 4.00 a.m. on Saturday Duration 7th May, 2005 and 2.00 a.m. on Sunday 8th May, 2005.
  - 3. No person shall park a vehicle on-

Parking prohibited

- (a) Reid Road;
- (b) Guapo-Cap-de-Ville Road, between Bryce Road and Point Ligoure Road;
- (c) Point Ligoure Road;
- (d) Millette Street:
- (e) Point Fortin Main Road, between Eagle Hall Street and Tank Farm Road;
- (1) Tank Farm Road, between Point Fortin Main Road and Guapo-Cap-de-Ville Road;
- (g) Wickham Street;
- (h) Canaan Road;
- (i) Sergeant Street, between Techier Main Road and Modeste Street;
- (i) Techier Main Road;
- (k) New Lands Main Road;
- (1) Volunteer Road;
- (m) Richardson Street;
- (n) Second Street;
- (o) Southern Main Road, between Point Fortin Senior Secondary School and Frisco Roundabout;
- (p) Point Fortin Old Road; and
- (q) Tanner Street.

Traffic routes

- 4. (1) Motorists approaching Point Fortin from the Southern Main Road shall turn right onto Techier Road, left onto Second Street, Techier Village, right onto Canaan Road, right onto Volunteer Road onto Clifton Hill Main Road onto Guapo-Cap-de-Ville Road, and onto Old Point Ligoure Road and exit via Reid Road.
- (2) Motorists leaving Mahaica shall proceed along Canaan Road and continue in the manner described in subclause (1).
- (3) Motorists leaving Point Ligoure shall proceed onto Guapo-Cap-de-Ville Road, right onto Reid Road and right onto Point Fortin Main Road.
- (4) Motorists leaving New Lands shall proceed onto Tank Farm Road onto Guapo-Cap-de-Ville Road onto Clifton Hill Main Road, onto Canaan Road, Mahaica, and exit via Techier Main Road.

Roads closed

- 5. Vehicular traffic is prohibited on the following roads:
  - (a) Mainfield Road;
  - (b) Bryce Road;
  - (c) Montano Street;
  - (d) Canon Street;
  - (e) Reid Road;
  - (1) Southern Main Road, between Point Fortin Senior Secondary School and Guapo-Cap-de-Ville Road;
  - (g) Lyle Street;
  - (h) Guapo-Cap-de-Ville Road, between Hilo Roundabout and Reid Road;
  - (i) Sylvester Street;
  - (i) Guava Road;
  - (k) School Road:
  - (1) Church Street; and
  - (m) Morris Street.

Removal and impounding of vehicles unlawfully parked

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
