ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(AUSTRALIA vs. WEST INDIES) (CRICKET) ORDER, 2003

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Australia vs. West Indies) (Cricket) Order, 2003.

2. This Order has effect from 6.00 a.m. to 7.00 p.m. on the following Duration days:

- (a) Saturday, 19th April, 2003;
- (b) Sunday, 20th April, 2003;
- (c) Monday, 21st April, 2003;
- (d) Tuesday, 22nd April, 2003;
- (e) Wednesday, 23rd April, 2003;
- (f) Saturday, 24th May, 2003; and
- (g) Sunday, 25th May, 2003.

3. Parking is prohibited on the following roads:

- (a) Tragarete Road, between Alexandra Street and Serpentine Road; Parking prohibited
- (b) Havelock Street;
- (c) St. Clair Avenue;
- (d) Kavanagh Street;
- (e) White Street;
- (f) the alley-way, between Havelock Street and Broome Street;
- (g) the alley-way, between Alexandra Street and Elizabeth Street;
- (h) Rosalino Street, between Roberts Street and Tragarete Road;
- (i) Pole Carew Street;
- (j) Serpentine Road, between Tragarete Road and Serpentine Place;
- (k) Elizabeth Street, between Tragarete Road and Hayes Street;
- (l) Damian Street; and
- (m) Taylor Street.

Parking  
restricted

4. Parking is restricted on—

(a) the western side of—

- (i) Broome Street;
- (ii) Alexandra Street;
- (iii) Gray Street;
- (iv) Serpentine Place;
- (v) Gallus Street, between Ariapita Avenue and Warren Street;
- (vi) Alberto Street, between Ariapita Avenue and Warren Street;
- (vii) Rosalino Street, between Ariapita Avenue and Warren Street;
- (viii) Luis Street, between Tragarete Road and Roberts Street;
- (ix) Alfredo Street, between Ariapita Avenue and Tragarete Road; and
- (x) Carlos Street, between Ariapita Avenue and Tragarete Road;

(b) the eastern side of—

- (i) Elizabeth Street, between Hayes Street and Serpentine Road; and
- (ii) Mary Street;

(c) the southern side of—

- (i) Flood Street;
- (ii) Jackson Street;
- (iii) Hayes Street;
- (iv) Sweet Briar Road, between Elizabeth Street and Alexandra Street;
- (v) Roberts Street, between Damian Street and Murray Street;
- (vi) Hunter Street;
- (vii) Brabant Street; and
- (viii) Hamilton Holder Street;

(d) the northern side of—

- (i) Jack Square North; and
- (ii) Seigert Square North.

5. Motorists on—

One-way  
traffic

- (a) Havelock Street, between St. Clair Avenue and Tragarete Road, shall proceed in a northerly direction only;
- (b) Elizabeth Street, St. Clair Avenue and Tragarete Road, shall proceed in a southerly direction only;
- (c) Rosalino Street, between Tragarete Road and Roberts Street, shall proceed in a southerly direction only; and
- (d) St. Clair Avenue, between Elizabeth Street and Roxy Roundabout, shall proceed in a westerly direction only.

6. There shall be no right turn from—

No right turn

- (a) Elizabeth Street onto Tragarete Road;
- (b) Sweet Briar Road onto Elizabeth Street;
- (c) Havelock Street onto St. Clair Avenue;
- (d) Kavanagh Street onto St. Clair Avenue; and
- (e) Broome Street onto St. Clair Avenue.

7. Motorists shall enter the King George V Car Park through the—

Entrance to  
King George V  
Car Park

- (a) northern entrance, by proceeding east along Western Main Road and turning north onto Serpentine Road;
- (b) south-eastern entrance or the south-western entrance by proceeding west along St. Clair Avenue; and
- (c) western entrance by proceeding north onto Havelock Street.

8. Without prejudice to any liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
