MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(POINT FORTIN BOROUGH DAY CELEBRATIONS) ORDER, 2000

1. This Order may be cited as the Traffic Restriction (Temporary Citation  
Provisions) (Point Fortin Borough Day Celebrations) Order, 2000.

2. This Order has effect between the hours of 10.00 a.m. on Duration  
Saturday 6th May, 2000 and 2.00 a.m. on Sunday 7th May, 2000.

3. No person shall park a vehicle on—

Parking  
prohibited

- (a) Reid Road;
- (b) Guapo-Cap-de-Ville Road, between Bryce Road and Point  
Ligoure Road;
- (c) Point Ligoure Road;
- (d) Millette Street;
- (e) Point Fortin Main Road, between Eagle Hall Street and  
Tank Farm Street;
- (f) Tank Farm Street, between Point Fortin Main Road and  
Guapo-Cap-de-Ville Road;
- (g) Canaan Road;
- (h) Sergeant Street, between Techier Main Road and Modeste  
Street;
- (i) Techier Main Road;
- (j) New Lands Main Road;
- (k) Volunteer Road;
- (l) Richardson Street;
- (m) Second Street, Techier Village;
- (n) Southern Main Road between Eastern Avenue and Frisco  
Roundabout;
- (o) Point Fortin Old Road;
- (p) Wickham Street; and
- (q) Tanner Street.

## Traffic routes

4. (1) Motorists approaching Point Fortin from the Southern Main Road will turn right into Eastern Avenue (opposite Point Fortin Senior Secondary School), left into Second Street, Techier Village, right into Canaan Road, left into Richardson Street, right into Guapo-Cap-de-Ville Road, left into Tank Farm Road, right into Point Fortin Old Road to the Guapo-Cap-de-Ville Road.

(2) Vehicles leaving Mahaica will proceed along Canaan Road and continue in the manner described in subclause (1).

(3) Vehicles leaving Point Ligoure will proceed into Point Fortin Old Road, into Tank Farm Road, right into Guapo-Cap-de-Ville Road, and continue as in subclause (1).

(4) Vehicles leaving New Lands will proceed into Tank Farm Road and continue in the manner described in subclause (1).

## Roads closed

5. Vehicular traffic is prohibited on the following roads:

- (a) Mainfield Road;
- (b) Bryce Road;
- (c) Montano Street;
- (d) Canon Street;
- (e) Lyle Street;
- (f) Sylvester Street;
- (g) Guava Road;
- (h) School Road;
- (i) Morris Street;
- (j) Reid Road;
- (k) Church Street;
- (l) Southern Main Road, between Eastern Avenue and Guapo-Cap-de-Ville Road; and
- (m) Guapo-Cap-de-Ville Road, between HiLo Roundabout and Reid Road.

Removal and

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
