ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(CORPUS CHRISTI) ORDER, 2000

1. This Order may be cited as the Traffic Restriction (Temporary Citation
Provisions) (Corpus Christi) Order, 2000.

2. This Order has effect between the hours of 7.30 a.m. and Duration
12.30 p.m. on Thursday, 22nd June, 2000.

3. Parking is prohibited on the following roads:

- (a) Independence Square North, between Nelson Street and
Wrightson Road;
- (b) Independence Square South, between Nelson Street and
Wrightson Road; and
- (c) George Street, between Independence Square North and
Independence Square South.

Parking
prohibited

4. Vehicular traffic is prohibited between the hours of 8.30 a.m. Vehicular
and 11.30 a.m. along the following roads: traffic
prohibited

- (a) Independence Square North, between Wrightson Road and
Nelson Street;
- (b) Independence Square South, between Nelson Street and
Edward Street;
- (c) Richmond Street, between London Street and
Independence Square North;
- (d) Edward Street, between Independence Square South and
Queen Street;
- (e) St. Vincent Street, between Queen Street and Independence
Square North;
- (f) Chacon Street, between Queen Street and Independence
Square North;

- (g) Frederick Street, between Queen Street and Independence Square North;
- (h) Charlotte Street, between Queen Street and Independence Square North;
- (i) Broadway, between South Quay and Independence Square South, with the exception of the taxis specified in paragraph 5(a); and
- (j) Queen Street, between Edward Street and Richmond Street.

Taxi stands 5. Taxis assigned to the following taxi stands shall operate as follows:

- (a) taxis assigned to taxi stands on Independence Square North and on Cipriani Circle, shall operate from the western side of Broadway, between Independence Square South and South Quay facing south, entering and leaving by way of South Quay only; and
- (b) taxis assigned to taxi stands on Abercromby Street, Chacon Street, Henry Street, Charlotte Street and George Street, shall operate from their respective stands facing south, entering and leaving by way of South Quay only.

Chap. 48:50 6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
