MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(HOSEIN) ORDER, 2001

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Hosein) Order, 2001.

2. This Order shall have effect from—

- (a) 10.00 p.m. on Sunday 1st April, 2001 to 4.00 a.m. on Monday 2nd April, 2001;
- (b) 10.00 p.m. on Monday 2nd April, 2001 to 4.00 a.m. on Tuesday 3rd April, 2001;
- (c) 10.00 p.m. on Tuesday 3rd April, 2001 to 4.00 a.m. on Wednesday 4th April, 2001; and
- (d) 10.00 a.m. to 7.00 p.m. on Wednesday 4th April, 2001.

3. Parking and vehicular traffic are prohibited on the following roads:

- (a) Western Main Road, between Long Circular Road and George Cabral Street;
- (b) Nepaul Street, between Western Main Road and Hyderabad Street;
- (c) Clarence Street, between Western Main Road and Anderson Street;
- (d) Dengue Street, between Western Main Road and Anderson Street;
- (e) Ethel Street, between Western Main Road and Finland Street;
- (f) Lazarrie Street, between Western Main Road and Carlton Avenue;

- (g) Romeo Street, between Western Main Road and Carlton Avenue;
- (h) Mathura Street, between Western Main Road and Carlton Avenue;
- (i) Bengal Street, between Western Main Road and Delhi Street;
- (j) Agra Street, between Western Main Road and Delhi Street;
- (k) Madras Street, between Western Main Road and Delhi Street;
- (l) Calcutta Street, between Western Main Road and Delhi Street;
- (m) Bombay Street, between Western Main Road and Church Street;
- (n) Mooneram Street between Western Main Road and Church Street;
- (o) Brunton Street, between Western Main Road and Church Street;
- (p) Bournes Road, between Western Main Road and Church Street;
- (q) Jerry Street, between Western Main Road and Church Street; and
- (r) Salazar Street, between Western Main Road and Church Street.

Parking
prohibited

4. Parking is prohibited from 12.00 noon to 8.00 p.m. on the following roads:

- (a) Vidale Street, between Western Main Road and Anderson Street;
- (b) Nizam Street, between Hyderabad Street and Western Main Road;
- (c) George Cabral Street, between Kathleen Street and Western Main Road;
- (d) Cawnpore Street, between Hyderabad Street and Western Main Road;
- (e) Kathleen Street; and
- (f) Delhi Street.

5. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
