MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(ST. PETER'S DAY CELEBRATIONS—CARENAGE) ORDER, 2001

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (St. Peter's Day Celebrations—Carenage) Order, 2001. Citation

2. This Order has effect between the hours of 10.00 a.m. and 10.00 p.m. on Sunday 1st July, 2001. Commencement and cessation

3. Vehicular traffic is prohibited along the Western Main Road, between Abbe Poujade Street and School Street. Vehicular traffic prohibited

4. Parking is prohibited on the following roads: Parking prohibited

- (a) Haig Street, between Western Main Road and Francois Street;
- (b) Beard Street, between Western Main Road and Francois Street;
- (c) Constabulary Street, between Western Main Road and Sobrian Street;
- (d) Hope Street;
- (e) Abbe Poujade Street, between Western Main Road and Haig Street;
- (f) School Street, between Western Main Road and Francois Street; and
- (g) Francois Street, between School Street and Beard Street.

5. Vehicular traffic shall proceed— One-way traffic

- (a) in a northerly direction only, along—
 - (i) School Street, between Western Main Road and Sobrian Street;
 - (ii) Beard Street, between Sobrian Street and Hope Street; and
 - (iii) Abbe Poujade Street, between Western Main Road and Haig Street;

- (b)* in a westerly direction only, along—
 - (i) Sobrian Street;
 - (ii) Hope Street, between Beard Street and Haig Street;
and
 - (iii) Raymond Street, between Haig Street and Abbe
Poujade Street;
- (c)* in an easterly direction only, along—
 - (i) Hope Street, between Haig Street and Beard Street;
 - (ii) Francois Street, between Beard Street and School
Street; and
- (d)* in a southerly direction only, along—
 - (i) Haig Street, between Hope Street and Raymond
Street;
 - (ii) Abbe Poujade Street, between Raymond Street and
Western Main Road;
 - (iii) Haig Street, between the intersection of Abbe
Poujade Street, Haig Street and Hope Street;
 - (iv) Beard Street, between Hope Street and Francois
Street; and
 - (v) School Street, between Francois Street and Western
Main Road.

contravention of this Order may be removed by the Police and
impounded and dealt with in accordance with section 108(1)(b) of the
